Havana papers by the steamer Alliance to the 25th ult. contain, as usual, very little from the seat of insurrection. The Diario says that the last steamer at Sabanao represents order and tranquility prevailing in Santiago de Cuba and its vicinity; the music of the military band (100) being observed in the plaza. A party of immigrants was hovering in the neighborhood and leaving contributions of horses and arms upon the plantations. This paragraph is significant.
