Commercial Intelligence.

REVIEW OF THE MARKET.—The general trade of the city has progressed satisfactorily since the date of our last review of the market, Friday evening, February 26. Operations in the leading staple have been particularly active throughout, however, owing to the important drawback designated under the commercial heading. Tobacco has been quiet and firm. Sugar and molasses have been in very light supply, and more restricted demand at retail prices has been the result. Flour is still scarce and in request at former prices, but all other staples are in ample supply at previous rates. Corn, oats, bran and hay have exhibited but very limited activity, and quotations of all have been only moderate. Bacon and lard have been dull and drooping throughout, while lard has been in moderate supply and demand at previous figures, and pork has still further advanced, although the offerings have been ample, and the inquiry has been only moderate. Foreign exchange is scarce and weaker, and domestic exchange shows a steady diminution of offerings at rapidly enhancing figures.

Commercial Intelligence.

COTTON.—Transactions in cotton have been restricted, irregular and drooping from the date of our last review, Friday evening, Feb. 26, up to the present writing. Advances from Liverpool and New York have been for the most part adverse to the interests of holders, and a foreign exchange rate, still within a day or two, uniformly ruled in favor of buyers of the leading staple. There has been no evidence of doubt or uncertainty at any stage, notwithstanding the fact that with regard to the future, however, and the principal lists on sale have been kept under cover throughout from the opening of the week. Some disappointment has been felt at the apathy exhibited in Liverpool on receipt of our reports, but holders have come to look upon the matter of still higher prices as merely a question of time; and in conditions to meet the worst that may come, they seem perfectly indifferent.
