few resolutions that might cause trouble for his own brethren. A caucus chairman and floor leader is usually selected by the voting representatives of each party. Some of the old days when men were sometimes accused of playing politics in legislative affairs, a floor leader was considered a good investment. From a caucus leader handed out advice to the members who had not as yet learned their seat numbers and the best time to vote to the best political advantage. This year the Republicans, the Democrats and the Progressives each elected floor leaders. But up to the time when the legislators took up its grind this morning, at least, no ordinary legislative observer could have guessed which party the various floor leaders represented.

In former sessions when an administration failed to put through its platform promises, its campaign orators dragged a copy of the house or senate journal and showed that the opposition voted against them. Consequently nothing was done. It is an old, time honored alibi. But in the campaign of 1915, the house journal will not be used. It will show that the house was as unanimous as a mass convention in the interest of universal peace.

Possibly in keeping his forces closely allied with those of the opposition, Mr. Doerr is playing a clever, crafty game of politics that is far above the understanding of the legislative observers. LEGAL. SENATE BILL NO. 528. AN ACT to amend the provisions of the foot and mouth disease act to make appropriations therefor.

Whereas, the disease foot and mouth disease has its appearance in four counties in this state, and

Whereas, an emergency exists whereby the welfare of the live-stock industry of this state is menaced, and the entire state irretrievably injured, and so

Section 1. That there is hereby appropriated out of any money in the state treasury not otherwise appropriated the sum of ten thousand (\$10,000) dollars, or so much thereof as may be necessary, to be made immediately available.

Section 2. That the auditor of state is hereby authorized and directed to draw his warrants in favor of the state live stock sanitary commission upon the verified statements of such commissioner that the same is made necessary by the efforts of his department to check the ravages of said disease.

Section 3. This act shall take effect and be in force from and after its publication in the official state paper. I hereby certify that the above Bill originated in the Senate, and passed that body February 2nd, 1915.
