BY AUTHORITY.

RULE AND REGULATION BY THE
BOARD OF COMMISSIONERS OF
AGRICULTURE AND FORESTRY,
CONCERNING THE IMPORTA-
TION OR INTRODUCTION INTO
THE TERRITORY OF HAWAII
OF BIRDS, REPTILES AND IN-
SECTS INJURIOUS OR DETRI-
MENTAL TO AGRICULTURE,
HORTICULTURE OR FORESTRY.

The Board of Commissioners of Agri-
culture and Forestry hereby make the
following Rule and Regulation:

SECTION 1.—For the purpose of pre-
serving and protecting the forests and
the agricultural and horticultural in-
terests of the Territory of Hawaii, all
persons, companies and corporations are
hereby prohibited from importing or in-
troducing into the Territory of Hawaii or
into any of its ports for the purpose of
debarcation into the said Territory, any
live animal or animals known as "Flying
Fox" (Pteropus) or "Fruit Eating Bat,"
or any other animal, bird, reptile or in-
sect injurious, or liable to become in-
jurious to forests, trees, plants, or other
vegetation of value.

SECTION 2.—If any animal, bird,
reptile or insect is imported or introduced
into the Territory of Hawaii, or into any
of its ports for the purpose of debarcation
into the Territory of Hawaii, contrary to
law or this regulation, the same shall in
the discretion of the Board of Com-
missioners of Agriculture and Forestry
or its duly authorized agent, officer or in-
spector, be immediately destroyed or
deported at the expense of the importer
or introducer, and the person or persons
or corporation introducing or importing
the same shall be guilty of a misdemeanor
and shall be liable to the penalty or pen-
alties provided by law.

SECTION 3.—This regulation shall
take effect from and after the approval
thereof by the Governor.

RULE AND REGULATION BY THE
BOARD OF COMMISSIONERS OF
AGRICULTURE AND FORESTRY,
CONCERNING THE IMPORTA-
TION OR INTRODUCTION INTO
THE TERRITORY OF HAWAII
OF FRESH FRUIT FROM EAST
AND WEST INDIES, ASIA, AUS-
TRALASIA, OCEANIA, MALAY-
SIA, MEXICO, CENTRAL AND
SOUTH AMERICA.

The Board of Commissioners of Agri-
culture and Forestry hereby make the
following Rule and Regulation:

SECTION 1. For the purpose of pre-
venting the introduction into the Terri-
tory of Hawaii of fruit flies, their larvae
or pupae and other insects injurious or
liable to become injurious to trees,
plants, fruit or other vegetation of value,
all persons, companies and corporations
are hereby prohibited from introducing
or importing into the Territory of Haw-
aii, or into any of its ports for the pur-
pose of debarcation into the said Terri-
tory, any fresh fruit from East or West
Indies, Asia, Australasia, Oceania, Mal-
aysia, Mexico, Central or South America.

SECTION 2. If any fresh fruit shall
be imported or introduced into the Terri-
tory of Hawaii, or into any of its ports
for the purpose of debarcation into said
Territory, contrary to law or this regu-
lation, the same shall, in the discretion
of the Board of Commissioners of Agri-
culture and Forestry or its duly authorized
agent, officer or inspector, be immediately
destroyed or deported at the expense of
the importer or introducer, and the per-
son or persons or corporation introducing
or importing the same shall be guilty of
a misdemeanor and shall be liable to the
penalty or penalties provided by law.

SECTION 3.—This regulation shall
take effect from and after the approval
thereof by the Governor.

JAPANESE BEGIN OFFENSIVE OPERATIONS PREPARATIONS FOR PORT ARTHUR ATTACK

(By Wireless to THE TRIBUNE.)

Tokio, Japan, Nov. 21.—The Japanese operations at Port Arthur are proceeding as prearranged.

Mukden, Nov. 21.—There is rumored Japanese activity on both Russian flanks.

Another Battle Imminent.

Mukden, Manchuria, Nov. 18.—It is believed there will be a battle on Friday.

Chinese in Manchuria Will Assist.

Harbin, Manchuria, Nov. 18.—Chinese bandits are active. The Japanese are enlisting Chinese militia at thirty cents a day.

Russian Confidence in Port Arthur.

St. Petersburg, Russia, Nov. 18.—The authorities are confident that Port Arthur will hold out until the arrival of the battleship squadron of the Baltic fleet.

Yellow Peril Increased.

Mukden, Manchuria, Nov. 17.—It is reported that 60,000 Japanese have landed.

Developments Expected.

Mukden, Manchuria, Nov. 17.—It is believed there will be important military developments soon.

Japanese Entrenching Themselves.

Kuropatkin's Headquarters, Manchuria, Nov. 17.—The Japanese are strengthening their defenses on the Taitsi river.

Port Arthur Garrison Courageous.

Chefoo, China, Nov. 16.—The Port Arthur garrison is very confident that it will be able to hold out against the Japanese. General Stoessel reports his ability to hold the inner line of forts intact.

No Surrender Yet.

St. Petersburg, Russia, Nov. 16.—The report of General Stoessel, received today, denies that the Port Arthur garrison contemplates surrender.

Sakaroff Killed, Stoessel Wounded.

Chefoo, China, Nov. 16.—The death of General Sakaroff and the wounding of General Stoessel, commander at Port Arthur, is confirmed.

Japanese Ship Blown Up.

Chefoo, China, Nov. 16.—The Russians have blown up the torpedo boat destroyer Rastoropyny, which arrived here with dispatches from Port Arthur. Three Japanese torpedo destroyers arrived here last evening, being satisfied that the Rastoropyny had sunk.

Second Division Sails.

Libau, Nov. 16.—The second division of the Baltic fleet sailed today for the Orient.

King of Portugal Arbitrator.

St. Petersburg, Russia, Nov. 16.—The King of Portugal will probably be the fifth member of the North Sea Commission.

To Inspect Isthmian Canal.

Washington, Nov. 18.—Secretary of War Taft has started for Panama.

United States Attorney General.

New York, Nov. 18.—It is reported that President Roosevelt has offered former Governor Black the Attorney Generalship.

Swanzy Succeeds Montsarrat.

Honolulu, Nov. 17.—F. M. Swanzy has been elected President of the Planters' Association, succeeding Julian Montsarrat, retiring officer.

Hawaiian Sugar Arrives.

Philadelphia, Pa., Nov. 16.—The American-Hawaiian steamship Hawaiian arrived here today, and brought the captain and crew of the brig C. C. Sweeney, which was abandoned off Cape Henry.

A Hawaiian Schooner Wrecked.

Victoria, B. C., Nov. 20.—The Hawaiian schooner Makaweli was wrecked off Clayoquot yesterday. The entire crew was lost. Hind Rolph & Co. are owners.

Roosevelt Cleans Alaska.

Washington, Nov. 16.—President Roosevelt has removed Marshal Richards of Nome, Alaska, and requested the resignation of Judge Brown.

New York, Nov. 21.—Twelve persons were burned to death today in a tenement house fire.

St. Louis, Mo., Nov. 20.—The Missouri building at the World's Fair was burned today.

HONOLULU WILL HAVE CURFEW BELL SOUNDED

Honolulu, Nov. 18.—The curfew law now standing on the statute books is to be enforced by the order of the High Sheriff.

[For years the Curfew law was in force in Honolulu and many a youngster was compelled to stay indoors at night, when he otherwise would not. When the old station house on King street in which hung the curfew bell, was destroyed by fire in 1887, the practice was discontinued. Sheriff Henry has inaugurated the observance of the curfew law again, which is as follows:

Sec. 406. Any child under fifteen years of age, who, except in case of necessity, shall go or remain on any public street or highway after nine o'clock in the evening and before four o'clock in the morning, unaccompanied by an adult person, shall be punished by a fine of not more than five dollars or by imprisonment not exceeding fourteen days.

Sec. 407. Any parent or guardian, having the care, custody and control of a child under fifteen years of age, who, except in case of necessity, shall knowingly and voluntarily suffer or permit such child to go or remain on any public street or highway, after nine o'clock in the evening and before four o'clock in the morning, unaccompanied by an adult person, shall be punished by a fine of not more than ten dollars or by imprisonment not exceeding twenty days.]

New Court Stenographer.

Miss Kate Kelly did not arrive by the last Kinau to take the position of court stenographer in Judge Parson's court, and it is understood she will not assume her duties until after the work of the present court term is finished. Her appointment was requested by Governor Carter for political reasons, and Secretary Atkinson endorses her application. No dissatisfaction is expressed regarding Mr. Springer's work as official stenographer, but the change is made to satisfy certain demands.

The Value of Wireless.

Commenting on the naval lessons of the present war between Russia and Japan, an officer high in the Russian navy, makes the following statement:

"The greatest lesson has been the usefulness of wireless telegraphy. In the fighting of August 10—we used the wireless system in signaling until the apparatus was shot away. We found it worked more reliably and quicker than flags. I believe that in the near future every ship in all the navies, even gunboats, will be fitted with wireless apparatus.

"Much has been learned about mines and torpedoes. The only defense against mines is good judgement, or insight as to where they are likely to be placed by the enemy. If it is imperative that ships must go to that vicinity, send 'sweepers' in advance. The war has demonstrated that the most powerful searchlights cannot pick up floating mines, which were unknown before this war.
