Holders of water privileges, or those paying water rates, are hereby notified that the hours for irrigation purposes are from 6 to 8 o'clock a. m. and from 4 to 6 o'clock p. m. II. Holders of water privileges on the slopes of Punihouli above Green street, and in Nuuanu Valley above School street are hereby notified that they will not be restricted to the irrigation hours of 6 to 8 a. m. and 4 to 6 p. m., but will be allowed to irrigate whenever sufficient water is available, provided that they do not use the water for irrigation purposes for more than four hours in every twenty-four.
