## FROM KAU DISTRICT.

Concerts for the Lepers on Molokai and Other Notes.  
Kau, Hawaii, November 28.—The people of Kau have held two concerts recently for the benefit of the lepers on Molokai. The proceeds which amount to quite a considerable sum, will be sent to the poor unfortunates as a Christmas gift from the people of Kau.

The first concert was given at Waiohina under the direction of Sam Kauhane, assisted by Ulukou, Thos. Martin, Makakoa and others. Mrs. Lee presided at the piano. The house was crowded and \$85 was taken at the door.

The second one was given at the Pahala school house on the night of November 26. The building was crowded to its utmost capacity and \$90 was taken in.

Messrs. Thos. Martin, Ulukou and Makakoa rendered valuable services as did the Punaluu Glee Club under the leadership of J. W. Kuimoku. Miss Alice Smith sang a solo that brought down the house. The Misses de Carma gave recitations that were greeted with great applause. Great credit is due Jos. Lono Jr. for his work on the stage.

Captain King, Minister Cooper and W. E. Rowell passed through the district, remaining two days at Punaluu. Their work in the district was the inspection of roads.

Mr. Nowell is taking R. Ziegler's place as book-keeper at Pahala while the latter is in San Francisco trying to regain his health.

The Noeau was expected here to take Hutchinson S. P. Co.'s sugar so as to make connection with the Australia, but she is weatherbound off the Hamakua coast.

Honusapo and Pahala mills are still grinding. Strong trades and a lumpy sea prevails at present.
