

MAUI CANDIDATE MAY BE BARRED. (Special to the Bulletin) Wailuku, Maui, Oct. 19.—M. R. Keohokalohe, the Home Rule candidate for Auditor, filed his nomination papers with County Clerk Kase last Wednesday morning.

"AFTERNOON SESSION. Board came to order at 2 p. m. Church presiding. Reuter, Meyer, Cornwell and Church present. Henning came in later (3 p. m.).

"The following is a copy of the resolution introduced by Mr. Cornwell, No. 678, for the payment of a claim of \$682.85 by 32 laborers on the New Iao road, viz: "Wailuku, Maui, T. H., Oct. 4, 1906.

"No. 678. Mr. Cornwell presents and moves the adoption of the following resolution: "Be It Resolved by the Board of Supervisors of the County of Maui, T. H., that we hereby approve Pay Roll Demands numbered 1628, and the Auditor and Treasurer of the County of Maui are hereby notified that the above numbered Demands have been approved and ordered paid out of the appropriation known as account New Iao Road.

"Motion seconded by Reuter, Reuter, Cornwell, No. none. Total, 4." According to the above resolution, which was one of the many introduced by Mr. Cornwell, it was Mr. Cornwell himself who moved the adoption of the resolution favoring the payment of \$682.85 to the 32 laborers who worked on the Iao road during the month of July.

"In his haste to pass many resolutions to his credit that day in order to earn his monthly stipend, Mr. Cornwell never examined carefully these claims which he now howls about before his constituents, and makes political capital out of it by saying that he wants a party to such a shady transaction.

"And even if he did know about it, then he intentionally laid a beautiful snare to catch other members of the Board of Supervisors in order to burn them up later on the political forum, as he is doing with evident success at present. But the effect of it will rebound to his injury, for politicians of such stamp are better annihilated than allowed to sow seeds of discord and dividing means for the defraying the expenses to be incurred in this connection. The latter part of the program was left largely in the hands of the treasurer, but the fixing mapped out the former fully, meeting the dates when the candidates are to enlighten the public upon their superiority over others in the different districts.

"All the candidates at large are to meet at Lihue on Saturday the 20th, when they will address the voters at the Social Hall at 7:30 in the evening. The next day being Sunday they will travel as far as Hanalei where they will rest up for the strenuous week that lies before them.

"Monday, the 22nd, there will be meetings at Haena in the forenoon and Waialeale in the afternoon. In the evening they will address the voters at Hanalei.

"Tuesday the 23rd will see the candidates at Kilauea, where there will be a meeting at noon. In the evening they will be heard at Kapaa, where they can be heard at the Court House.

"Wednesday the 24th, Koloa will have a change in the evening to hear what they have to say.

"Thursday, the 25th, will be devoted to Hanalei, also in the evening. Friday the 26th they will arrive at Kekaha and in the afternoon will say a few words in behalf of the Republican party and themselves to the residents of the second precinct.

"Friday the 26th will see them safely through the hardest part of their labor when they have addressed the voters of the times.

"The committee also decided that the committeemen at the several precincts should make the necessary arrangements for places where the several

CIVIC FEDERATION PICKS CANDIDATES. Opposes Brown, Gear, Vida And Chillingworth For Office. CATCART COMPLIMENED BUT THAYER ENDORSED.

The Civic Federation has finally come out in the open and has announced the candidates whom it will support and those it will oppose. It claims that it has investigated their records and upon this it divides them into three classes—those it endorses, those it opposes, and the rest, as follows:

Candidates Endorsed by the Civic Federation For the Territorial Senate—D. Kalaupokalani, C. J. McCarthy, W. O. Smith.

For Representatives—Fourth District: A. D. Castro, John A. Hughes, Ed. Ingham, E. A. C. Long, E. W. Quinn, W. T. Rawlins. Fifth District: S. P. Correa, H. W. Lelele, Ed. L. Liko, J. L. Pao, J. M. Poopea. For Sheriff—C. P. Iulkea. For County Attorney—W. W. Thayer. For County Treasurer—R. H. Trent. For County Clerk—D. Kalaupokalani Jr. For County Auditor—James Bicknell.

For Supervisor at Large—W. W. Harris, F. R. Harvey. For County Supervisors—S. C. Dwight, J. J. Fern, C. H. Hueston Jr., Honolulu; J. Paete, Koolau; Andrew Cox, Waianae and Wailua; Frank Archer, John Defries, Ewa. For Deputy Sheriffs—W. P. Jarrett, Honolulu; Frank Pahlia, Koolau; L. B. Nainoa, Koolaula; Oscar Cox, Waialua; R. L. Gilliland, M. K. Lelele, Waianae.

There are several cases in which a word of explanation with reference to the above list of endorsed candidates is called for. The Federation deems the office of Sheriff the most important in this campaign. The record of the present Sheriff is glaringly evident and needs no comment. The prostitution of the police force from its legitimate sphere is so complete that it no longer stands for public service. It has become the personal political weapon of its chief. The one imperative civic demand of the hour is to overthrow this corrupt and menacing political machine which is degrading and debauching our city.

There can be no question that the nominee of the Republican convention, Mr. Catcart, for County Attorney is by far the more capable criminal lawyer of the two candidates for this position. But he is so completely identified with the Brown machine that the interests of good government demand the election of Mr. Thayer.

The Federation finds it an unpleasant duty to drop from its endorsed list the name of such an excellent public servant as Mr. P. T. Waterhouse. His record in the Legislature was good and he should have been retained there. When the list of nominees for Representatives from the Fifth District is scanned, the action of the Republican Convention in failing to put Mr. Waterhouse in nomination for Representative assumes the dimensions of civic treachery. He should have been renominated and he could have been elected. But the machine took his name from this position in order to use his popularity as a club to strike down Mr. R. H. Trent, the incumbent of the office. Mr. Trent has done superior service as County Treasurer, and deserves re-election on his record as a rebuke to the machine.

The Federation believes that Messrs. M. G. K. Hopkins and C. H. Rose are excellent candidates for the offices for which they have been named. But the Civil Service Reform principle, defended for years by our honored president and everywhere widely accepted by the American people, ought to prevail in Hawaii, namely: that a faithful, efficient, public servant should be retained in office. Messrs. D. Kalaupokalani Jr. and Jas. Bicknell fill this requirement and they deserve reelection.

The second list of candidates comprises those whose election the Civic Federation opposes. They are as follows: Candidates Opposed by the Civic Federation For the Senate. A. M. Brown, for Sheriff. A. V. Gear, for Supervisor, Honolulu. H. C. Vida, for Deputy Sheriff of Honolulu.

The third list comprises the names of all the other candidates not contained in the above two, and whom the Civic Federation can not see its way clear to endorse. There seems no need to print their names.
