## QUEEN'S ALLOWANCE IS RAISED TO \$700

SENATE.

Forty-Eighth Day—Afternoon Session. In the Committee of the Whole yesterday afternoon the Senate raised the appropriations for salaries, maintenance of hospitals, promotion work, charity purposes and several other matters.

The Queen's monthly allowance was raised to \$700 from \$625. The appropriation for promotion work passed at \$9666 and other items for maintenance of hospitals and charity work were liberally passed.

Robinson asked an appropriation of \$1300 for pay rolls and \$7200 for the maintenance of Mahalani Hospital in Waialuku. Smith in seconding the motion said that the institution has been very useful on the island of Maui. The item passed. Hilo Hospital, on motion of Brown, was given an appropriation of \$11,500. Harvey moved that \$7200 be appropriated for the Kapiohoni Maturity Home. All the above items passed.

Knudsen, who was presiding, called out to Fairchild to look after the Kaula hospital, but, unfortunately, he was not in, and hence no appropriation was secured for the Kaula hospital.

**Supreme Court.** The salary for clerk of Supreme Court passed at \$129 a month. Henry Smith, who has been clerk of the Judiciary department for many years, will, it is said, be given another position in the First Circuit.

Stenographer and clerk pay passed at \$25 a month. Assistant clerks, billfolds, librarians and messengers were given \$3600 a year.

The salaries of all the interpreters of the First Circuit, including the Hawaiian, Japanese, Chinese and Portuguese, were fixed at \$125 a month.

The clerk of the Second Circuit was given a salary of \$125, and a special appropriation of \$2500 provided for stenographer's hire.

Cochran wanted the expense allowance of the court raised to \$19,000 from \$7500. Failed.

The salary for the clerk of the Fourth Circuit was raised from \$125 to \$150 a month. The assistant clerk was given \$125 and Hawaiian Interpreter \$100. The appropriation for a Portuguese Interpreter was stricken out.

**Archives.** The salary of the Superintendent of Public Archives passed at \$125. Baker moved that a salary of \$100 be appropriated for a translator of the archives. His motion failed, but on motion of McCarthy an appropriation of \$5000 passed. This item included the salary of a translator.

**Queen's Allowance Raised.** On motion of Baker, which was adopted, the allowance of Queen Liliuokalani was raised from \$625 a month to \$700. Chillingworth, in supporting Cochran's motion to increase it to \$650, stated that she had been the Queen of the people and in order to keep up the dignity, though she is living in private life, it was necessary to give her a decent allowance. McCarthy was ashamed of making a small raise of \$25. He suggested that a decent raise be made, which passed according to Baker's motion.

**Promotion Support.** Chillingworth made an eloquent speech in support of the promotion work. He asked that \$6000 a year be provided. Carried. Baker wanted to know if the amount just appropriated included the bringing of immigrants into the Territory.

The Governor sent down the following message of appointments: "I hereby nominate and propose, with the advice and consent of the Senate, to appoint the following persons to the following offices:

On motion of Senator Chillingworth, action on the message was deferred until today.

Secretary Mott-Smith informed the Senate that the Governor had signed the following bills:

## GRAFT COMMITTEE HAS BEEN APPOINTED

HOUSE

48th Day—Afternoon Session. A committee was appointed yesterday afternoon by the Speaker to investigate into the charges of graft that have been flying back and forth about the House of Representatives ever since last Saturday. The committee, it was announced, was to begin its sittings at 10 o'clock this morning in the Speaker's private office. Shingle, Coney, and Kawewehi were appointed as the members of the committee. They could not say last night whether or not the hearings would be public, but it is probable that they will be on the star-chamber order, that being in line with Speaker Holstein's general policy as regards everything but matters of mere routine.

The Judiciary Committee, to which was referred the resolution presented Tuesday by Kalelopu for the appointment of an investigating committee, reported back a substitute resolution of the same general tenor as the original measure, and it was in accordance with the provisions of this resolution that the committee was appointed to nose out graft if there be any graft.

It was noticeable that Speaker Holstein did not appoint on this committee any of the insurgents. Kawewehi is a Democrat or a Home Ruler—he does not seem to be sure just which. Shingle has made the statement on the floor of the House that he believes in standing by the Speaker, right or wrong. Coney is another member of the "Cabinet" and generally backs Speaker Holstein up in everything the latter does—unless it is something that is liable to injure Kauai.

When the House arose yesterday the comment was freely made that the committee is to be a whitewashing committee, and that it will report back that it could find no evidences of graft. Several members asked why Cohen, Long, or Alfonso was not made a member of the committee instead of appointing three men who have steadfastly denied that there is any graft going on and who will have to be convinced against their own previous convictions.

Kamanoulu introduced a resolution which, if it were to become law, would virtually have the effect of shutting fish out of the markets of Honolulu.

The resolution is as follows: "Be It Resolved by the House of Representatives of the Territory of Hawaii, That the Board of Health be requested to direct its several fish inspectors to prevent the sale of any deep-sea fish or fishes that have been kept alive in any storage or fishing boat for more than twenty-four (24) hours after the same have been caught, and that said inspectors be given authority to prevent the sale of any such fish or fishes from any fishing boat or boats remaining away from its mooring in any harbor throughout this Territory for more than twenty-four (24) hours at any one time."

The Agricultural Committee, by its chairman, Shingle, presented a concurrent resolution relating to how the \$150,000 natural resources share of the immigration tax should be spent.
