NEW CREWS PREDICTED FOR ALL PACIFIC MAIL STEAMERS

Result of Attempt to Smuggle Chinese Ashore at San Francisco Alleged as Responsible for Sweeping Change—Inter-Island Steamers Depart With Christmas Cheer.

A considerable shake-up has taken place among the stewards and deck department in the Pacific Mail liner Manchuria, and before this vessel steamed out of the harbor this morning the prediction was freely made that practically a brand new staff of Chinese, in both the stewards', navigation and operating departments of the liner, would be secured during the stay of the vessel at Hongkong. The alleged sweeping of the steamer of her Asiatic employees is said to arise from the attempted smuggling of fifteen Chinese men and women, who barely escaped being caught at the last minute as they were being conveyed from the Manchuria to San Francisco by means of a rowboat.

General Manager Szwedzin is said to have taken steps to conduct a rigid inquiry into the attempt to smuggle the Celestials ashore. He stated before the departure of the vessel from San Francisco that while little progress had then been made, he hoped to be assisted greatly by the investigation of the customs and immigration officials. He was convinced that none of the officers of the Manchuria in high authority are at all responsible. It is possible that some one of the watchmen may have had cognizance of the plot, but in his opinion the sole responsibility rests with the Chinese crew.

Hoodoo for Hindoos.

There were eleven Hindoos on board the Pacific Mail liner Manchuria that sailed out of the harbor of Honolulu at an early hour this morning who are firm believers that there is a large and well developed hoodoo following their course since they first departed from the shores of the Indian peninsula.

These men of a party of but fifteen who took passage in the Manchuria at Hongkong and upon arrival at San Francisco were taken in hand by the United States Marine Hospital and Quarantine authorities. With the exception of four, the party was found to have been too intimately associated with that arch enemy of industry, the hookworm. The Indians spent the time allotted to the Manchuria remaining at San Francisco as guests of the government at Angel Island. According to the officers in the Man-

In Everett five years ago, arrived in Everett, towing the four-masted schooner Virginia, ninety-seven hours after leaving the Golden Gate. The vessel encountered heavy weather off the Columbia river, but the Virginia was held safe all the way by the Paulsen. The Virginia brought 180 tons of California wild hay.

T. K. K. Plan for Independent Agency.

In completing arrangements for the conduct of their business along independent lines, the Toyo Kisen Kaisha is reported to have appointed K. Iwasa, acting manager of the Yokohama Specie Bank, to act as sub-agent for the Japanese steamship company at Honolulu. The general agency for the company at this port will be handled through Castle & Cooke according to prediction some three months ago, through Japanese advisers.

Lumber and Fertilizer for Hawaii.

The freight list of the Inter-Island steamer Mauna Loa that sailed for Kona and Kau ports at noon today included extensive shipments of lumber and fertilizer. The vessel departed with a fair list of cabin and deck passengers. A portion of the mail intended for westward Hawaii ports was transferred to the Mauna Loa.

Helene Off for Hawaii Ports.

Taking a general cargo including shipments of fertilizer, lumber and other lines of freight, the Inter-Island steamer Helene was dispatched for Hawaii ports shortly after moon today. The vessel will call at Mahukona and Kawahae before returning.

Cattle from Hawaii.

A shipment of cattle to the number of sixty head have arrived at the port by the Inter-Island steamer Kaula. The vessel will take on a general cargo for the Big Island. The officers report fine weather with light winds and smooth seas.

Noeau for Kauai Ports.

The Inter-Island steamer Noeau has been placed on the berth to sail for Kauai ports at five o'clock this evening. The vessel is taking general cargo.

ICED BEER WAS THEIR UNDOING

The city and county coffers were enriched to the tune of two hundred dollars this morning as a result of a visit paid by two Japanese hotel proprietors at the bar of justice presided over by District Magistrate Lymer.

The vending of the iced beer of commerce was the medium that brought trouble to Messrs. Myamoto and Hirano, who conduct places of entertainment on Kukui street.

Each acknowledged that he had been caught dead to rights by L. I. Fennell, inspector and his assistance. They had been found with the goods in their possession. Fennell raided the places of business the other evening, and in his search for incriminating evidence secured an array of drinkables that would bring the gleam of joyousness to the most care-hardened and thralld-ridden resident of these blessed isles.

Beer in bottles, some lead and ready for parched throats, was dragged from obscurity. Demijohns of wines were brought within the scope of the Fennell drag net.

The Japanese were represented at court by legal counsel who stated that a plea of guilty might be entered. Counsel asked that leniency be observed in assessing a penalty.

The minimum fine of one hundred dollars and the costs of prosecution were levied in each case. The defendants were given until Saturday to make the payment to the court clerk.

American Steamer Missing.

LONDON, December 7.—The American steamer Arkadia, from New Orleans October 11 for San Juan, has been posted as Lloyd's as missing.

Japanese Steamer Lost.

VICTORIA (B. C.), December 10.—The Japanese steamer Kumamoto Maru, 1998 tons, was lost with her crew of thirty-four men, November 27th, off Sado island, while bound from Muroran to Tsingtao with ties. A number of bodies were washed ashore on the island. In the same storm the steamer Taihei Maru went down off Akita Prefecture and ten of her crew were drowned. The steamer Goman Maru was damaged off Sado island, but reached shelter.

Autos and Mail for Hawaii.

Taking a large mainland mail that arrived here by the Pacific Mail steamer Manchuria, and a shipment of merchandise including three automobiles from the von Hamm-Young garage the Inter-Island steamer Mauna Kea departed from her wharf about an hour late this morning. The vessel is bound for Hilo by the way of Maui and Hawaii ports of call. There was a fair number of cabin and deck passengers. The Municipal band was on hand and played the vessel off.

LORENZO SIMPLY WOULD BUTT IN

Lorenzo, a young man of Porto Rico an extraction simply butted in while a Hawaiian gentleman was correcting the wife of his bred and board by the employment of something more strenuous than mere words of admonition. Yet it cost Lorenzo thirty dollars.

The long veranda of a River street tenement was the scene of a social soiree which brought the Porto Rican before District Magistrate Lymer this morning upon a charge of assault and battery. The allegation made by the Hawaiian couple was that the man from Porto Rico had thrown a large section of building stone which had lodged with a dull sickening thud against the good right arm of the Hawaiian. Lorenzo claimed that he resided in the same apartment house as does the Hawaiian couple. He further stated that the married life of the pair was far from being one long drawn out dream of bliss. They were fighting, and the afflicted cries of a woman apparently in distress was the siren call that brought him to the scene of affray.

The woman's husband resented the intrusion of the Porto Rican and he did not attempt to conceal his displeasure over the appearance of Lorenzo upon that part of the land near his apartment. Some rather insulting language was used by the Hawaiian in addressing Lorenzo which he resented with the result that he picked up a large stone and cast it at his detractors.

Lorenzo may decide to board out a portion of his fine at Hotel Aech.

MOTORISTS SPED NOT WISELY BUT TOO WELL

Messrs. T. J. McGrath, W. H. Stewart and Clarence Macfarlane contributed a trifle over five dollars to the operating expenses of the City and County of Honolulu this morning as a result of the activities displayed a week ago last Sunday by Special Officer W. R. Chilton, who stationed himself on Beretania Avenue and kept tab on a number of autoists and motorists who were exceeding the prescribed speed limit for such vehicles.

The defendants appeared in court and were assessed the minimum fine by District Magistrate Lymer. Each pled guilty to the charge and admitted that the record maintained by Officer Chilton was correct to the best of their knowledge and belief.
