THE STATE NORMAL SCHOOL.

Among the prominent features of the Act of General Assembly establishing a uniform system of Public Instruction is the State Normal School.

The object is to instruct and train teachers of Public Schools in the science of education, the art of teaching and the mode of governing schools.

It is strictly a professional institution, and holds relatively a special position towards our Public Schools, that the West Point Military Academy or the Naval School at Annapolis does to the army or navy of the nation.

It is the teacher who is the key-stone in the school room. It is he who has the power, that we have in the liberal appropriations and judicious plans adopted for the training of an accomplished class of native teachers.

The Normal School will be located in Baltimore, where the Mayor and City Council provide suitable buildings for its reception.

It will undoubtedly receive the prompt attention of the next Council, and soon will have the gratification of seeing in full operation this training school for teachers, with its schools of practice of different grades.

In completing the new Central High School in Park street, arrangements should be made to accommodate the Normal Classes, thus giving those who are preparing for the responsible duties of the school room an opportunity to witness and profit by the systems of instruction practically exhibited by the able High School Faculty in their several classes.

We would prefer, however, to see a separate building dedicated to this purpose of training young men and women in the best method of teaching and conducting Public Schools; a building which will be an honor to the municipality and an evidence to those who visit our rapidly increasing city that all things connected with public instruction are to be well done.

An outline of the Normal School law will be prepared, and it is hoped that those who purpose to engage in the work of the teacher.

It provides for the education of 250 persons, young men and young women, who, being instructed and furnished with the use of text books at the public expense, agree to teach for a stated period in the Public Schools.

These normal students are appointed from the city of Baltimore and the counties, two for each-teacher of the House of Delegates, and one for each Senator.

The principal of the school of Public Instruction, and prescribes the course of study, supervises the curriculum and provides for the establishment of model primary and grammar schools as schools of practice.

In these schools the normal pupils will be engaged as teachers, and verify by experiment the systems of instruction in which they are trained.

The school consists of four professors, two of them men—two women, each having a distinct department of instruction. The first professor has already been selected, and brings the highest evidence of fitness for the important and responsible position which he will occupy.

The delay in occupying the building is due to the want of the appropriation of the City Council, and the fact of being able to take up the subject of providing buildings for its accommodation, will give Prof. Newell ample opportunity to aid in devising a thorough system of instruction, and to inspect the normal institutions of other States.

It is of great importance that Maryland should have the benefit of the experience of those States which have preceded her in developing efficient systems of public instruction, and specially in this matter of training teachers. It is a true proverb that the teacher makes the school. Water cannot rise higher than its source, and the grade of energy and intelligence of the pupils will be in equilibrium with that of the preceptor.

In order that the teachers now engaged in school work may derive benefit from the superior methods of instruction which the normal professors will impart, the law provides for two sessions of the school in Baltimore, continuing through six months. The remaining four months of the school will be appropriated to the counties, in each of which a Teacher's Institute will be held annually, presided over by the county superintendent, aided by a professor from the Normal School.

The whole State will reap the immediate benefit of normal instruction. New methods of teaching and proper modes of discipline will be imparted to the preceptors, who, for many years, have been engaged in public school work, and a degree of uniformity promptly secured, which, through the Normal School alone, would require many years.

We wish full success to the noble institution, and hope that our city authorities will co-operate cheerfully and liberally with the State Board of Education in carrying out the provisions of the law.
