### Order of Publication.

Christian Egner, against Alexander Siers and Rebecca Siers his wife, and Ezekiel A. Mail and Eliza Mail his wife.

The object of this suit is to procure a decree for the sale of certain mortgaged premises lying in Allegany County, Maryland, which were on the 6th day of September, 1859, mortgaged by the defendant, Alexander Siers, to the complainant.
