THE CITY COUNCIL.

Annual Reports of Various City Officers Submitted-The Medical College Tangle.

There was quite a breezy session of the Council last evening, and while a great deal of time was wasted in talk much important business was transacted.

The City Treasurer submitted his report for the year ending December 31, 1884, making the following financial showing: Total receipts, \$763,900; disbursements, \$768,975.71; balance on hand January 1: Tomlinson fund, \$68,871.84; additional City Hall fund, \$45,749.94; sinking fund, \$59,845.91.

The City Clerk submitted his annual report showing that orders amounting to \$752,548.71 had been drawn on the Treasurer during the year 1884. He also presented a statement of the bonded indebtedness of the city and an interest coupon statement showing the amount of interest payable each year.

The Committee on Contracts recommended that the contract for the construction of the stone abutments of the Farnes' Railroad bridge at East street be awarded to John Whitsett, he being the lowest and best bidder; also, that the contract for constructing the bridge complete be awarded to the Indianapolis Bridge Company at \$4,251.69.

The Finance Committee submitted a report showing that the expenses for the year of 1884 were \$348,650.83, and that the revenue for the year was \$543,250. The committee's report says: "The hospital improvements of \$27,450 add quite a figure in this year's expenses, otherwise we would be considerably inside of our revenue, and are convinced that a ninety-cent levy, with care and economy, will be sufficient to meet all necessary requirements."

The report was concurred in. Mr. Bingham moved that a committee of five be appointed to see what can be done to lessen the expenses of the city government.

Several lengthy petitions, signed by the members of the Central College of Physicians and Surgeons and their friends, were received, protesting vigorously against the recent move of Superintendent Wheeler, of the City Hospital, in depositing Dr. Eastman, of the City Hospital staff, and charging that the aforesaid college was being discriminated against because it is not allowed as large a representation as other colleges. A heated discussion ensued immediately after the reading of the petitions, and Mr. Hough moved that the entire matter be referred to a committee of five for investigation, which was done.

Mr. Frenzel Resigns.

Mr. John P. Frenzel, one of the Board of Police Commissioners, yesterday handed his resignation to Governor Gray. It reads as follows:

To His Excellency, Governor Isaac P. Gray, Hon. W. K. Myers, Secretary of State, Hon. James H. Rice, Auditor of State, Hon. John J. Cooper, Treasurer of State:

GENTLEMEN:—I hereby tender my resignation as a member of the Board of Metropolitan Police Commissioners of the city of Indianapolis to take effect immediately.

In severing my connection with this very important department of the city government, I take this occasion to express regret at the dissolution of the very pleasant official relations which have existed since the organization of the board.

A Sentinel representative called upon Mr. Frenzel in the afternoon, and asked if he had anything to say as to the causes leading to his resignation. He replied that his reasons were fully stated in his written resignation in the hands of the Governor, and further than that he had nothing to say.

Mr. Murphy was seen in the afternoon, and said that he was very much surprised to hear of Frenzel's resignation. He said that the relations of the members of the board had always been of the friendliest character, and that Mr. Frenzel had proved himself a very efficient and useful member.

An effort was made yesterday to induce Mr. Frenzel to reconsider his resignation, but with what effect cannot now be stated.

The Rinks.

The two-mile race at the Wigwam Rink last night between Chester Spain and A. B. Cutler was a hotly contested one from the start, and created considerable excitement among the audience, who evinced their enthusiasm by frequent outbursts of applause. Mr. Cutler was the victor by a few feet, in 8:49. Although the weather was very cold the audience was a large one, nearly all the seats being occupied. On Thursday evening the first of a series of races for the championship of the city and a gold medal will be skated, the distance of this race being one mile. There will be the usual matinee on Wednesday afternoon, with good music.

This evening a three mile race will take place at the College Avenue Rink in which M. Salters, of Tipton, C. Spain and Walter Dean will participate. This will be one of the most exciting races ever witnessed in this city, as each contestant claims the "belt" and to night's speeding will settle the matter. There will also be a hand-to-hand race between Charles Timberlake and Harry Dickerson, who are only six years old, for a gold badge. Go and enjoy the sport.

THE YEAR'S FIRES.

Annual Report of the Fire Department to the Council—Some Interesting Figures.

The annual report of the Fire Department was submitted last night to the Council by Chief Webster. The report was made out by Joe Gaspar, and one as neat as his former work in this line. The report shows an allowance of \$16,463 besides salaries for the proper conduct of the business, while the list of expenses shows an aggregate of \$13,439.05. The report says: "During the past year no body of men ever performed their duty better or with more willingness, having shrunk from no duty, however difficult or hazardous, most especially at our last and largest fire, the cotton mill, for by such desire to do their duty unflinchingly was the mill saved from total destruction."

The monthly losses were as follows: January, \$7,490.23; February, \$6,674.37; March, \$4,389.80; April, \$7,171.25; May, \$895.50; June, \$4,439.07; July, \$1,425.00; August, \$2,765.41; September, \$2,872.06; October, \$1,425.00; November, \$3,806.97; December, \$4,362.26.

Amount of insurance over losses, \$692,741.67. The losses during 1884 were \$425,806.01; 1883, \$52,160.99, and 1882, \$110,579.09. Of the origin, forty-seven were incendiary and defective flues of the buildings, 110 were residences, fifty-five stables, thirteen factories and twenty-two business blocks.

The New Adjutant General.

Governor Gray yesterday appointed Captain George W. Koontz, of the Miller Grenadiers, of Richmond, Adjutant General of the State. Captain Koontz has accepted the position and will take his position to-day. The salary of the Adjutant General is \$1,200 annually, and a clerk is allowed, who is paid out of the military contingent fund.
