

**CAUTION TO TRAVELERS COMING SOUTH**

South-bound passengers are cautioned against giving credence to the handbills and placards issued by the Bay Company between Baltimore and Norfolk, and to induce travelers to take their lives, publishing a long and tiresome statement purporting to be from a traveler, that by the mail route passengers going South are 24 hours later than by the Bay line, and that they are subjected to a personal supervision of their baggage at the North Ann River, to walk a considerable distance down a steep hill and up another in the middle of the night, involving both exposure and risk.

As a proof of the truth of the great mail route it may be mentioned that in the last 100,000 miles conveyed on it within the last five years, not a single passenger has been seriously injured.
