STEEL BRUSH COTTON GINS. THIS GIN is made under the patents granted to B. D. Gullett, of Aberdeen, Miss., in 1853; was formerly manufactured by Gannett, Chapman & Co., of New Orleans, and is the best of the kind ever made, and is now made only by the Myrtle River Manufacturing Company, under the personal supervision of Mr. B. D. Gullett, the inventor. The peculiar advantages of this gin are: First, The quantity of cotton given in a given time is much greater than by any other gin of an equal number of saws. A gin of eighty saws turns out ten bales per day. Second, It separates from the cotton more dust and neps and leaves it clearer from nap than any other gin made. Third, The effect of the steel brush is to straighten out the lint - removing all the knots and causing it to unplug a partial carding process. Fourth, The roll cannot be broken by over-feeding. It does not amper.
