CORPORATION STATE OF ARKANSAS,
VA. Department, Richmond, Feb. 1, 1864.

1. All prisoners brought to head by the United States authorities, whether soldiers, sailors or civilians, received at City Point before the first of January 1864, are hereby declared exchanged.

2. All officers and men of the Vicksburg capture, who reported for duty at any place, Mississippi, at any time, prior to the 14th of November 1863, and whose names were forwarded to me by Major General John H. Forney, are declared exchanged.

3. All officers and men of the Vicksburg capture, belonging to the 1st Tennessee Heavy Artillery, who reported for duty at Marietta, Georgia, and whose names were forwarded to me by Col. A. Johnston, are declared exchanged.

In obedience to the above, all paroled prisoners belonging to Louisiana organizations will report on or before the 31st day of May, 1864, at the following camps, viz:

17th and 21st Regiments Louisiana Infantry at Minden, La.

27th Regiment Louisiana Infantry at Shreveport, La.

3d, 20th, and 28th Regiments Louisiana Infantry at Camp Sabatry, near Natchitoches, La.

SOLDIERS! Your commanding officer trusts that every man of this command will do his duty, and report to camp without delay. For surely the veterans of the five years of the war of 1848 and 1849, of 1861 and 1862, cannot, after these glorious victories, prove false to their past fame and their colors, and that too, when the gallant men of our own and our sister States are so nobly battling for the right upon the soil of Louisiana. If, however, there be any so lost to honor as to linger at home and refuse to report, to such I would say that they cannot occupy the service they owe their country, as they will be sought for and arrested by cavalry, and afterwards deprived of all arrears in pay, and be treated as deserters. All commissioned officers failing in their duties will be reported to the General commanding this Department, to have their names stricken from the rolls and reported to the Bureau of Conscription. It would cause me great regret to be compelled to resort to these degrading measures with soldiers who have hitherto behaved so gallantly in every field; but it is a duty I owe the country and the good men of the command to see that justice is meted out to all.

All leaves of absence and furloughs in hands granted by these Head Quarters are hereby revoked. All men of this command who have joined other organizations will report as above.

It is desired that every soldier should report provided with a good blanket, or a pair of blankets; come prepared as well as circumstances will permit to take the field; as you will not be detained in paroled camps, arrangements having been made to exchange this brigade, which will doubtless be effected before the men can assemble in camp.

Treasury Notice.

AGENCY OF TREASURY
For Trans-Mississippi Department
(Houston, April 7, 1864.)

Notice is given to all holders of Treasury Notes not bearing interest, that they may exchange them at the office of any Depository of the Treasury, for Certificates which will entitle them to four per cent. Bonds, until the first day of July next. After that date, all Notes over the denomination of five dollars are taxed thirty-three and one-third per cent., and can only be funded or received for taxes at 66 2/3 cents on the dollar; and one hundred dollar notes will, after that date, not be receivable for public dues, and can be funded only subject to an additional tax and reduction of ten per cent. per month. On the first of October next, five dollar notes will also be subject to the tax of 33 per cent.; and after the first of January, 1865, all Treasury Notes of the present issue, cease to be fundable or receivable for public dues.

The Certificates issued, and Bonds for which they may be exchanged, are receivable for taxes, dues and payments during the year 1864, for the amount expressed on the face without interest; and are not subject to the tax imposed for that year on other bonds and credits.

For convenience in funding, additional Depositories will be appointed, and the several Depositories of the Treasury are authorized to appoint Deputies in convenient places to receive deposits for funding; to whom the principal Depositories will forward Certificates for the amounts received.

The short time allowed for funding should admonish all holders promptly to present their notes, and not risk the chance of exclusion by the pressure which will operate at the end of the month of June.

Collectors of Customs are notified that Treasury Notes are no longer receivable for Import Duties, Bunker's dues and Import Duties must be paid in cash by all parties.
