LAND REFORM.

Very soon now Louisiana will again take her place in the sisterhood of States, and the seats belonging to her in the national capital, and which have been vacant for seven long years, will again be filled by her representatives.

The government, since its foundation, has sold or given away 415,000,000 acres of land—an area large enough to make fifteen States of the size of Louisiana.

Now, of all this vast body of land only about 70,000,000 acres have gone into the hands of actual settlers.

There are now before Congress schemes that threaten to absorb all the public lands that the government still retains, and which amount to about one thousand millions of acres.

MAJOR KEELER'S TELEGRAM TO "THREE HEADQUARTERS."

The following telegram was received by Brevet Major General Buchanan on Saturday and was paraded on Sunday in the rebel papers with the capital heading: "The action of General Buchanan fully sustained at Washington."

WASHINGTON, June 13, 1868. General B. C. Buchanan, Commanding Fifth Military District.

Your action is sustained. The officers elected under the new constitution can not be installed without your consent, and it is deemed advisable for you to await the act of Congress now about to become a law before permitting the Legislature to meet or officers to be installed.

If this community is not greatly mistaken Major General Buchanan ordered that our State officers should be installed in November. The act of Congress referred to fixes the time for the installation of State officers several months earlier than the time especially designated by the Commanding General.

A NATIONAL BOARD OF TRADE. Much good to the entire country may result from the formation of the "National Board of Trade" which has just been completed at Philadelphia by a convention of delegates from the various trades associations of the several States.

The position assumed in a Camp street journal concerning "military interference with the judiciary," and referring to the order of General Buchanan setting aside an injunction from the Fourth District Court to restrain the collection of the Convention tax, is plainly untenable.

By the first section of the third reconstruction act it is declared to have the true intent and meaning of the preceding acts; that hereafter said government, if continued, were to be continued subject in all respects to the military commanders of the respective districts, and to the permanent authority of Congress.

There is no question as to what under ordinary circumstances may be the jurisdiction of the Fourth District Court of New Orleans, but simply as to whether this court, being now part of the "provisional" government which is "subject in all respects to the military commanders of the respective districts and the permanent authority of Congress," can now set aside this authority and declare unconstitutional that which Congress in the exercise of its paramount power has directed to be done.

THE ADMISSION OF LOUISIANA.

We publish the bill for the admission of Louisiana and other Southern States as it passed both Houses of Congress. Among those who voted for its passage in the Senate were Senators Ross and Trumbull. Van Winkle was paired with Hendricks, of Indiana. No Republican voted against the bill.

The first section of the bill provides for the admission of the States to representation in Congress when the Legislatures shall ratify the amendment to the Constitution known as article fourteenth.

The second section provides that the Legislatures shall meet at the end of twenty days from the time the act takes effect, unless the governor elect shall sooner convene the same. Governor Warmoth did not probably delay action in the premises.

The third section provides for the inauguration of State officers without delay after the Legislature ratifies article fourteen of amendment to the Constitution of the United States. The same section makes it the duty of the President within ten days after receiving official information of the ratification of said amendment by the Legislature to issue a proclamation announcing that fact.
