ARKANSAS.

The Kuklux Code—Murders and Church Burnings—Assault Upon a Sheriff—Accident to Governor Clayton.

(Special Dispatch to the Missouri Democrat.)

LITTLE ROCK, September 21.—The Kuklux Democracy killed one negro in Lewisburg and three in Columbia county, and burned some negro churches in Columbia.

In some rebel counties armed and masked Kuklux prowled about nearly every night. The Sheriff in Ashley county was assaulted while trying to execute the laws.

Governor Clayton was accidentally shot, on Saturday, in the left hand, which has been amputated.

GEORGIA.

State Militia Bill Defeated—Adjournment October 6.

ATLANTA, September 25.—The bill to organize and call into service the State militia was defeated in both Houses.

The House adopted a resolution to adjourn on the sixth of October, and refused to reconsider the bill amending the Constitution removing the capital to Milledgeville.

EUROPE.

La France on Nicaragua Treaty—Royal Troops Missing to Attack Reville.

PARIS, September 25.—The French are the rights gained by the United States in the treaty with Nicaragua were also gained by France and England by the stipulations of the treaty of 1850.

In the Senate, Tuesday, September 27, an act to authorize the Mayor and Common Council of New Orleans to issue bonds for the redemption of city notes and for the liquidation of their indebtedness, being under consideration:

Mr. Fouté: If we would not be guilty of enacting a comedy and a farce with this character of bills, I would refer them to the city delegation. A bill was submitted covering the substance of this bill, but containing more. I am in favor of the substantial object of this bill, but do not think it enough. I have suggested, and it has met the approval of all the financiers I have consulted upon the subject, that we should pass a bill, not to get the money, but to have the Legislature provide, first, that the plates upon which any denomination of this money whatever shall be printed be destroyed.

Mr. Ray: My only object is to have the bill referred. A discussion of its merits is hardly in place at present.

The motion which has been presented by the committee composed of the city delegation was retired, temporarily, upon the motion of Senator Braughn, for one week, until the next session of the Senate.
