Patrolman H. Reary, third precinct. Charge, ill treating a prisoner while in his charge. Case dismissed, the prosecutor having failed to appear.

Patrolman W. Nickerson and A. Daniels, fourth precinct. Charge, neglect of duty, lying down and asleep on their beats. Pleading guilty, and fined two days' pay each.

Patrolman L. Soublet, fourth precinct. Charge, neglect of duty, and being absent from his beat; found guilty, and fined five days' pay.

Special Patrolman T. McGowan, fourth precinct. Charge, neglect of duty, sitting down and asleep on his beat; pleaded guilty, but on account of mitigating circumstances the case was dismissed.

Patrolman A. Bibb, W. W. Jackson and L. Leo, sixth precinct. Charge, neglect of duty, absent from duty without leave; pleaded guilty, and fined one day's pay each.

Patrolman F. E. Miles, sixth precinct. Charge, neglect of duty, absent from duty one night; pleaded guilty, and reprimanded. The following resignation was tendered and accepted: Patrolman S. C. Wilson.

CITY COUNCIL.—Mayor Flanders, presiding, and present, Messrs. Shaw, West, Pierce, Emley, Walton, Delaisize.

Mayor Flanders informed the Council that the late Mayor had handed him a statement of the Giro fund, and had turned over the sum of four hundred dollars. Referred back to Mayor Flanders.

A communication from Mr. Cronan, asking for a release from his contract to collect duties of Tremé Market, was read and referred.

The subject of Metropolitan tax assessment was taken up.

Mr. Walton moved to amend by changing a date from the seventeenth of September to the thirtieth of the same month.

The tax is to be three-fourths of one per cent, and to be collectable after the promulgation of the ordinance. Adopted.

Mr. Emley's ordinance to govern the measurement of wood and coal was laid over.

An ordinance relative to the public markets, appointing inspectors, abolishing the office of commissaries, etc., was adopted.

An ordinance defining the duties of the Department of Commerce, and perfecting its organization, was read.

Mr. Shaw expressed a belief that the ordinance left extending toward common street, State Central Committee, Republican Party, Parish Executive Committee, Republican Party, First Ward Republican Club, Second Ward Republican Club, Third Ward Republican Club, Concordia Legion, Third Ward, Benevolent Associations of the First District, etc.

Mr. West made some extended remarks in opposition to portions of the ordinance, explaining where he thought it was wrong. He said that the ordinance as read swallowed up most of the other departments. He believed the ordinance in conflict with the charter.

Mr. Emley was unable to see in what manner his ordinance encroached on the privileges or duties of other Administrators, and denied that he was arrogating to himself anything; he had followed the spirit of the law.

Subject postponed.

Mayor Flanders thought that if each department should assume to take exclusive control of its office, he would find nothing to do, and he did not propose to draw his salary without earning it.

Mr. Walton offered a resolution concerning certain licenses, which had been issued by the late authorities to many persons for sums less than is required by law. The subject will be investigated.

Mr. Shaw introduced a resolution, appropriating gratuities to charitable institutions of this city. It is simply carrying out an existing law.

Mr. Shaw offered an ordinance to provide for the extinction of the floating indebtedness of the city of New Orleans, and the issue of bonds for the payment thereof. Lies over.

A substitute takes the same course.

Mr. Shaw's ordinance making the city's fiscal year begin on the first day of January, annually, was adopted.

Mr. Delaisize, by resolution, is authorized to advertise for supplies to the Waterworks.

Mr. West offered a resolution looking to the sanitary condition of this city, and like subjects, which was ordered to be printed.

Mr. West offered a resolution declaring two contracts with J. J. O'Hara annulled. Adopted.

The same administrator offered an ordinance to define the duties of his department. Lies over.

Rules to govern the Council were adopted.

Mr. Pierce proposed to enter into an election for five School Directors for the city as proposed to law.

Messrs. W. T. Mead, W. Van Orden, S. A. Stockdale, J. L. Tiesot, and William Grant were chosen.

These, together with six members by the State, will constitute the School Board.
