That if the bank had considered itself absolutely bound, it would have paid no attention to the notice given by Strauss not to pay it, as, according to the theory of the case, Strauss had no control over the amount against which the check was drawn. We have already stated the Sergeant Cambias, who has been deviously promoted to the grade of captain, has had thirty additional men transferred to his command, for the purpose of proleing the levee.

PROTECTION ON THE LEVEE.

This will double the force heretofore detailed for night duty on the levee, and as this additional force will be employed more especially to patrol the freight portion of the levee, say from Esplanade street to Felicite street, the merchandise thereon will be more secure from pillage than before this efficient addition of force was detailed.

PROTECTION ON THE LEVEE.

There has been, we know, a considerable complaint on account of the extensive stealing that takes place on the levee from night to night. A few of the complainants, (a very few, however), are disposed to visit the blame for this on the police force, as now organized. But, it should be borne in mind, that stealing on the levee, and perfectly systematized stealing, has been practiced ever since there was freight on the levee to steal.

PROTECTION ON THE LEVEE.

Since the institution of the recent Metropolitan Police force, the number of men detailed for night duty on the levee has been altogether too small for the work to be performed. Whether it be more or less than the force employed under former police organizations, we have no immediate means of ascertaining. But we believe that for many years past the amount of police force employed on the levee, was by no means commensurate with the always increasing requirements of commerce. For there is, of course, a species of red-tapeism in the administration of police affairs as well as in other departments of the public service.
