Accounts from Paris represent a disposition to resist the Prussians to the last extremity. Fresh armies are being organized in France to march to the protection of Paris.

The Empire has been abolished and a Republic proclaimed by the Corps Legislatif, Gambetta, Jules Favre and Jules Simon are the Directors. There is the wild excitement. The Orleans Princes start for Paris. Napoleon has been sent to Magdeburg. The Prussians are again marching on Paris.

NEW YORK, September 5.

The Provisional Government is assembled at the Hotel de Ville. Rochefort is addressing the meeting. Etienne Arago is Mayor of Paris. The Empire is gone. People are thronging the Tuilleries. Placards are posted, "Death to Thiers!" There are a hundred thousand people in procession. All Paris is in the streets.
