CHARTER. STATE OF LOUISIANA. City of New Orleans. Be known that on the first day of August, A. D. eighteen hundred and seventy, before me, Joseph C. ...

ARTICLE I. The name and title of the corporation shall be "Cosmopolitan Mutual Aid Life Insurance Association of New Orleans."

ARTICLE II. This Corporation shall be located and have its term in the city of New Orleans. It shall exist for a term of ten years...

ARTICLE III. The object of this association shall be to contract for the insurance of lives and to do all acts relative to that kind of insurance...

ARTICLE IV. All directors shall be vested in nine directors, of whom seven shall form a quorum. The first Board of Directors, who shall be appointed...

ARTICLE V. This association shall be composed of two classes of policy holders, each separate and distinct from the other, and shall be designated as follows: First class...

ARTICLE VI. Every male admitted a member of this association to the class designated as the first class, shall be required to pay...

ARTICLE VII. Each person admitted a member of the association to the class designated as the second class, shall pay into the treasury...

ARTICLE VIII. The following named persons shall be officers of this corporation...

ARTICLE IX. It shall be the duty of the Secretary to keep a record of the proceedings of the directors, and if he also be the Treasurer...

ARTICLE X. Should the earnings of the association exceed the amount of the expenses...

ARTICLE XI. No member of this association shall be liable for any of the obligations of the association...

ARTICLE XII. This act of incorporation may be altered or amended, or the affairs of the association put into liquidation...
