General Meeting of District-Synagogue of Christian Dispensation. New York, April 25.—Letters from Paris to April 19 have been received. The intense hatred existing among the villos, police men and the gens d'armes is beyond all description.

I will illustrate what I mean: To-day a lieutenant in the national guards returned to the city in disguise, and he would gladly abandon the movement and return to his business, but he added, it is not possible. If I leave I am a deserter, a spy, and the commune will arrest me and probably put me to death in secret.

Many others are in the same fix, and men, too, high in authority and influence in the commune. Each man fears and distrusts his neighbor, and hangs on at the very edge of fear of being known as a backslider or branded as a traitor. I believe that two-thirds of the men of the commune are now serving against all their convictions their fate, and only serve because they hope for an easy escape.

Assay in prison, Flanens dead and Cluseret rising to almost dictatorial power are certainly not signs of a great commune, harmony growing out of such winners as are now governing Paris. This I mention because it is the approach of terrorism.

Foreigners who have lived here for thirty years tell me that Paris never saw what it sees to-day.

But there was one drawback, and that was the forlorn condition of the City Park. We know that it will absorb a large amount of money before the park can be what was contemplated for the purpose. It is obvious, too, that in the present state of the city finances, or as those finances will be for several years to come that much can not be done by the city administration to render the park a place of desirable resort for our citizens. It is not justification or authority that is wanted in this matter; it is money.

Yet, while we concede the pecuniary difficulties attendant upon any attempt to make the park, in a short time, what it will eventually become, there are those who indulge the hope that the proper authorities can inaugurate a system of gradual improvement, constantly going on, causing little expense, but little by little carrying out the objects for which the park was intended.
