CHARTER. CHARTER. STATE OF LOUISIANA-CITY OF NEW ORLEANS. Be it known that on this thirtieth day of December...

ARTICLE II. The name and style of this association shall be the CITIZENS MUTUAL FIRE AND BUILDING ASSOCIATION...

ARTICLE III. The objects and purposes of this Association are declared to be as follows: To acquire and own real estate; to subdivide the same into lots...

ARTICLE IV. The capital stock of this Association shall be one million dollars, divided into ten thousand shares of one hundred dollars each...

ARTICLE V. All the corporate powers of this Association shall be exercised and all its business managed by a Board of Directors, consisting of five members...

ARTICLE VI. The following named stockholders shall constitute the first Board of Directors who shall hold their office until the first Wednesday in February, 1872...

ARTICLE VII. On the first Wednesday in February, 1872, and annually thereafter, the annual meeting of the Association shall be held at the office of the Association...

ARTICLE VIII. The Board shall, at their first meeting in 1872, and annually thereafter, select from their number a President and Vice President...

ARTICLE IX. Should any member neglect or refuse to pay punctually his installments as they fall due, interest thereon shall be added at the rate of ten per cent per annum...

ARTICLE X. When this Association designs making contracts for building or for materials, it shall invite bids to be opened and if one or more bids are received...

ARTICLE XI. The stockholder shall, in any event, be made liable beyond the amount of his subscription to the capital stock of the Association...

ARTICLE XII. At the expiration of the charter, or sooner, if agreed, the Association shall be liquidated, its debts paid, and the balance divided among the stockholders...

ARTICLE XIII. The names of the stockholders, their residence and the number of shares held by each, shall be made up and set on file in a book to be kept in the office of the Association...
