Approval Bills Passed—Bridging the Ohio—Adjournment May 29—Nomination—The Rice Tariff—Admission of Articles Duty Free.

WASHINGTON, January 26.—(Herald.)—Some private bills passed, when the appropriation bill was resumed, and legislative, executive and judicial and pension bills passed.

Mr. Morrill introduced a bill bridging the Ohio river at or near Evansville. Adjournment resumed. Mr. Schurz's amendment that Congress do not adjourn until the fall of October is passed.

Mr. Sumner's similar amendment regarding the civil rights bill, was lost. Senators Rice, Spencer, Sumner and Tipton, only voting for it.

Cleared of these amendments, a resolution adjourning the twenty-ninth of May passed by a vote of thirty-six to twelve. The Senate then adjourned.

General Emory has been nominated for marshal of the Southern district of Florida, and Amos Morrill, district judge of Eastern Texas. Goddard's nomination was withdrawn.

Senator Norwood was before the Committee of Ways and Means, and spoke against the repeal of the rice tariff. Dr. Clift and Isaac Seelye, of Georgia, and Judge Talmdge, of New York, also spoke against repeal or modification.

A committee of conference upon allowing certain articles to enter duty free will meet on Monday. The disagreement involves duty, but definite action is expected on Monday.

WASHINGTON.
Cabinet Meeting—General Emory Thinks the Trouble Ended—Southern Claims Commission—Habcock and Porter.

WASHINGTON, January 26.—Postmaster General Creswell and Secretary Robeson were absent from the Cabinet meeting to-day.

General Emory telegraphs from New Orleans that he thinks the trouble has ended. The Southern claims commission had before it to-day the cases of John Alexander and James W. Batzer, of Clarke county, Virginia, and Charles B. Love, of Atlanta. The first named claimant is eighty-four years old.

Generals Habcock and Porter have asked the congressional committee now investigating the New York customhouse to summon them as witnesses.

CINCINNATI, January 26.—The candy manufacturer of M. Nathan & Co. was burned this evening. The stock almost entirely destroyed. The loss estimated as follows: Stock, \$35,000; machinery, \$10,000; \$20,000 well insured. The building was damaged about \$10,000.

In the Board of Aldermen to-day a resolution to invite the Grand Duke Alexis to visit Cincinnati was defeated, lacking a constitutional majority.
