

lector in place of the license itself shall be valid.
Twenty-first—From each and every butcher and market dealer of any kind, from each and every person who keeps a stand or stall in a market place...

Twenty-second—From every traveling agent or employe of any merchant, who sells or contracts for the sale of goods, wares and merchandise, by sample or otherwise...

Twenty-third—From every person who shall, when called upon to do so, fail to pay said license tax, shall be subject to a fine of one hundred dollars, recoverable as for other fines...

Twenty-fourth—Parties having more than one shop, store or other establishment, or who shall, in any profession, trade, calling or business, shall pay the tax on each separately.

Twenty-fifth—Each partner of any firm doing business in the State, in any line of occupation, whether as partner, or non-resident, active or silent, shall pay a license as herein prescribed.

Twenty-sixth—Parties having a tax assessed against them other than real estate, shall not receive a license, nor be permitted to occupy until they shall pay the tax due upon such assessment.

Twenty-seventh—All forfeitures collected as herein expressed in the country parishes or other districts, shall go to the parish or district treasurer, for the exclusive use of the poor of the parish, to be expended as directed by the police jury of the several parishes, or board of the Charity Hospital of New Orleans...

Sec. 2. Be it further enacted, etc. That from and after the passage of this act it shall not be lawful for any person or corporation to exercise, or to attempt to exercise, any of the trades, professions or occupations enumerated in the foregoing sections of this act, in the State, before paying the tax assessed thereon, and retaining a license therefor, if not duly licensed...

Sec. 3. Be it further enacted, etc. That the tax collectors for the parish of Orleans shall receive for the collection of licenses in their respective districts the following compensation, viz: The tax collector for the First District, five per cent on all licenses collected by him and paid into the State treasury; the tax collector for the Fifth District, ten per cent on all licenses collected by him and paid into the State treasury; the tax collector for the Sixth District, fifteen per cent on all licenses collected by him and paid into the State treasury...
