Address of the Republican Central Committee.

STATE CENTRAL COMMITTEE

Republican Party of Louisiana.

New Orleans, March 18, 1872.

To the Republicans of the State of Louisiana:

The Republican State Central Committee, having

in the discharge of the duties imposed upon them

by the last State Convention, arrived at the regular

period which has been set apart by the usages of

the party for its State Conventions, and having

therefore, deem the occasion suitable to address

these brief remarks upon the political situation to

their fellow Republicans. The quadrennial election

for a President of the United States occurs this

year. The election of this high officer of the

Republic, whose character and political views are

so important, especially to the Republicans of the

South, and whose selection almost decides our political

future for the next four years, and perhaps for the

whole future, makes this election one of the most

and most vital interest to all our people. We

trust that your unanimous sentiment

in favor of the Republican ticket, which we

trust we will have the honor to see you

at the National Republican Convention, and advise them

to send our best representative men to the Philadel-

phia Convention, to help in selecting a tried,

and unflinching Republican to be our next

President. Our State election is also of the great-

est importance. We have to elect a Governor,

Lieutenant Governor, Secretary of State, Auditor

of Public Accounts, Superintendent of Public Educa-

tion, Attorney General, a new General Assembly,

and Representatives in Congress. In fact, this

election is to determine a question still more im-

portant to us than who shall be the next President.

It is to determine for the next four years whether

the State government shall be Republican or Demo-

cratic; in favor of equal rights, or against them; in

favor of progress, education and improvement for

all people, black as well as white, or in favor

of white progress, education and improve-

ment, and opposed to equal advantages for

the black people; whether we shall retain all that

we have won and go forward, or whether we shall

lose all and go back to where we were at the close

of the war.

We wish plainly and distinctly to understand the

fact that all parties opposed to the Republican

party, whether under the name of Democrats, Re-

publicans, People's party, or any other title what-

ever, are simply the old Democratic party under

new names, and have for their object but one thing,

that is to throw the State government out of the

control of the Republican party and into the hands

of their enemies. Our people will also see that to

defeat the strong and determined efforts of the

party to gain control of the State, one thing is

the great essential, that all Republicans shall be

UNITE AND WORK TOGETHER. If we do this

victory is certain.

To this end, we cordially invite all true and

earnest Republicans, without regard to past differ-

ences, to unite in this convention and to nominate

such ticket and adopt such a platform as will

command the respect and support of the whole

people.

All good Republicans also desire that our party

shall, as we are assured it will, declare itself de-

cidedly, distinctly and definitely in favor of re-

franchisement, reform, redemption, and the re-

moval of all unnecessary burdens on commerce

and trade, and in favor of equal and just legisla-

tion for all interests and all classes of persons.

Apportionment of Delegates.

By authority vested in me, and in pursuance to

the following resolution unanimously adopted at

a meeting of the State Central Committee of the

Republican party, held March 18, 1872, at the

committee rooms, to wit:

Resolved, That the president of this committee

be authorized to appoint a State Con-

vention to be held at Mechanics' Institute, in the city

of New Orleans, at twelve o'clock M. on Thursday,

May 2, 1872, for the purpose of electing delegates

to attend the National Republican Convention

Board of School Directors.

The regular monthly meeting of the New

Orleans Board of School Directors came off

last night in the Council Chamber of the

City Hall.

The preliminaries having transpired, the

following list of new members were read:

M. Hahn, W. N. Mercer, V. E. McCarthy

and W. G. McConer. These take the

place of the outgoing members of the first

year. The names were placed upon the

roll, the objection that all had not yet re-

ceived their commissions being overruled.

The standing committees were then an-

nounced, and they were formed of the same

members as in the previous year, sub-

sisting the new.

The committee on teachers reported as

follows:

City School--Miss H. N. Brooks, vice J.

S. Couner, recording secretary, Mrs. McKay, vice

Mrs. Brooks, promoted.

Live Oak School--Miss Knight, adjutant

first assistant; Miss J. E. O'Brien, second

assistant.

Live Oak Boys' School--Mrs. E. N. Kepling-

er, adjutant; Miss Josephine Pierson, in

place of the former lady, promoted; Miss

Lizzie Smith, second assistant.

Chestnut School--Mrs. K. J. Ricker, ad-

ditional teacher; Miss Rose Todman, third

assistant.

All recommendations to take effect from

the first of January.

The report and recommendations were

adopted.

From the committee on high schools came

the report of purchases of text books and

apparatus, which were all approved.

From the committee on repairs came the

report of certain expenditures for renova-

tion, all of which were approved and

adopted. Besides these small works done

on various school houses, whereof the

bills had not yet come in. Among the ap-

proved accounts were the following:

To William Arms, for work done in 1871,

\$9000.

The report of the committee on high

schools providing for the purchase of a

piano was adopted.

Mr. Hahn, from the committee on music,

reported on this subject, that the system of

Mr. L. A. Seward worked well, and he of-

ferred a resolution that music and singing be

taught in all the schools, fifteen minutes

each day to be devoted to it, under inspec-

tion of the teachers, supervised by Messrs.

L. A. Seward and A. B. Chase, to receive a

salary of \$150 a month each. For services

already rendered, Mr. Seward to receive

\$300. The resolution was adopted as read.

The report of the committee on finance

on the subject of Chalmers school house

and renting the same, was approved.

Communications from teachers requesting

leave of absence, asking for pay, and for

reimbursement of pay already forfeited, as well

as applications of teachers for situations, were

read and referred.

From the committee on equalization of

salaries and their adjustment, the same

schedule of salaries previously agreed upon

in committee was reported. These salaries

were simply an approximation. In some

instances they were increased, in others de-

creased.

The report was amended, changing the

salary of second assistant from \$750 and

from \$720 into \$600. The whole matter was

then postponed until next meeting.

A resolution to rent two additional rooms

for pupils in the Live Oak School was

adopted, the same to be furnished with as

little delay as possible.

A resolution that the treasurer of the city

receive certificates of indebtedness in

payment of the school tax was read.
