Local Intelligence.

SHOT AT.—Sunday evening Officer Mason had occasion to arrest James Rankin in Algiers for cruelly beating a lad, Charles Albright. Rankin had a shotgun, and several persons with him were seemingly inclined to act belittlingly toward the officer. Mason's duty was plain to arrest him, and in his attempt to do so he was fired at by Rankin, and also out by him. The policeman, the same as a plain citizen, was bound to defend himself, therefore drew his revolver and returned the fire, slightly wounding Rankin. He now threatens to prosecute the officer for the same, with intent to kill. The officer and his witnesses unhesitatingly assert that the firing on his part was entirely in self-defense.

About seven o'clock, yesterday morning, the body of an unknown white man, about fifty years old, was found floating in the river, at the head of Canal street. The deceased had on black cloth trousers, gaiter shoes, red woolen knitted jacket, cotton-lined undershirt, white overshirt, and a mark of an old sore on the left cheek.

Also, about the same time, the police discovered floating in the river, at the head of Richard street, the body of another unknown white man, about forty years old, dressed in a linen duster, black pantaloons, coarse linen overshirt, slippers and woolen socks. The deceased had a red beard and mustache. Coroner Creagh held an inquest, and a verdict was returned of accidental drowning.

Liquors Buried Thirteen Years in a Sand-bar.

In the fall of 1850, or early in 1861, the steamer South Bend, bound from Cincinnati to the Arkansas river with a valuable cargo of liquors and general merchandise, was run into and sunk by a steamboat fifty miles above Memphis. She was owned by Thompson Dean and John D. Adams. Six hundred barrels of whisky and two hundred cases of brandy are treasures now sought for by Captain John Cowdon, who writes as follows to the Memphis Appeal:

SAND BAR, MISSISSIPPI RIVER, Near Island No. 26, October 7. EDITORS APPEAL.—To-day at twelve o'clock, after a seven weeks' search, I have struck the wreck of the steamer South Bend, in boring our eleven hundred and level and straight, as if on the docks. The decks are sound and unbroken, twenty-four feet deep under the sand, and about sixteen feet below the present stage of water.
