False sympathy for the South.

For the purpose of influencing the elec-

tion of next month, the vigilance com-

mittee has issued a circular for the white race

of the Southern States on account of the bad

government from which they have suffered

since the close of the war, and it is the op-

inion of the committee that the Republican

party is alone to blame for all the evils

with which the people of those States

are afflicted. A brief reference to a few facts,

and the exercise of a little reason, will show

that there is no foundation

for this clamor, and demonstrate that

our white Southern brethren are alone to

blame. All the misfortunes which they are

undergoing are the legitimate consequences of

the war. Their troubles have not been

induced upon themselves by their own

misconduct. The war, if true, if any exist

in the South, which we are inclined to

believe, is the result of their own attempts

to deprive others of the same political

rights which they claim for themselves.

No one can doubt that who will for a mo-

ment prevent the restoration of the Union

after the close of the war, when

the South lay prostrate and exhausted,

Northern men, seeking a more hospitable

climate, sought refuge in the Southern

States. They went there with

capital, energy, and a desire to build

up their waste places. Many of them were

intelligent and cultured, such as any com-

munity could desire to receive.

It is encouraged, they would have given life

and impetus to business, and enabled every

branch of industry to improve. Being

Northern men, the colored race, however,

rather than the colored race, were their old

masters, would have been guided and con-

trolled by these new men, who were gen-

erally in political accord with the negro,

and entertained no prejudice against the

race. This class of men would necessarily

have arrayed themselves upon the side of

good government, and lent their powerful

aid in securing it. Being used to it in the

North, they would have insisted upon its

being in the South. But emigrants from

the North were not tolerated. The doors

of the South were closed against them, and

they were excluded and live in the South,

except by the sacrifice of all that he held

dear. The result of this course of conduct

upon the part of the Southern people, was

that the better and more intelligent emigrants

were driven away, and the only Northern

men that remained were the real adventurers,

who went there to better his condition as

whenever a man of color is admitted into

the ranks of the white society he is

regarded as a man of color, and becomes the

leader of the latter that he might fill the

office and profit thereby.

Not content with re-

pellling white emigrants from the North,

the Southern whites made it upon the

blacks—those who would not ally with

the slaveholder, but who were really

looking to the betterment of the race.

Every device was resorted to

to deprive the former class of the newly

acquired rights, and thus the confidence

which really existed in the Southern

whites, and which was the basis of the

South, was destroyed. This was because

the prey of the white adventurers, the real

carpet baggers, who used them for their

own profit and advancement. And this, in

brief, is the history of the Southern

whites, and which will explain the

prejudice that have befallen the

Southern States. It was an inevitable

consequence that had men should get into

office, and being in office, should abuse

the power, and that a wiser, a more

liberal policy would have saved the

South from all this, and her white people

are alone to blame.
