REGULAR MEETING.

The Council met this day at twelve o'clock in regular session.

Present.—Hon. Charles J. Leed, Mayor, presiding, and Administrators Bertoli, Brown, Bony, Burke, Landry, McCarty and Pillsbury.

The minutes of the previous meeting were approved and their reading dispensed with.

Communications from the Mayor and Administrators.

The Mayor laid before the Council the following communication which was received and read:

CHARLES J. LEED, Mayor. I have the honor to report that in accordance with the advertisement of the honorable the Administrator of Waterworks and Public Buildings...

Received, and accompanying statement ordered to be filed.

DEPARTMENT OF IMPROVEMENTS. I have the honor to report that a dredge-boat has commenced the excavation of Nashville avenue canal...

Notice has also been served upon the company requiring them to open the canal to a width of ten feet.

The entire force of the Sixth District has been placed on duty for the principal streets of the Sixth District.

Financial and Other Business on Plant.

Mr. Brown called up the ordinances described as follows, which, having been read twice, were now on third reading...

An ordinance providing for the payment of the several accounts therein named, beginning "New Orleans Bulletin."

An ordinance appropriating \$125 for the maintenance of prisoners in the Seventh District in the month of December, 1874.

Mr. Burke reported on the many complaints of citizens of the Sixth District relative to the obstruction of gutters, etc., and called attention to ordinance No. 1096, Administration series.

By Mr. Landry, and adopted: Resolution canceling the bond of Thomas E. Burke, wharfinger, First District; granting permission to Thomas A. Enderle to erect a mill...

An ordinance providing for the exchange of bonds for premium bonds, in accordance with the plan adopted by the Council and approved by the Mayor on the twenty-fifth day of May, 1875.

It was further ordered, That all bonds funded or hereafter to be funded under this ordinance, be interest-free contracts, shall date from the first day of July, 1875, after which period the interest thereon shall cease.

It was further ordered, That a permanent committee of six shall be appointed to represent the bondholders in all matters touching their interests under and in this ordinance.

From Ames Methodist Episcopal Church, for cancellation of taxes. To the Administrator of Assessments.

Sealed proposals from P. J. Sullivan, proposing to make new brick batonnet, etc. as per advertisement, was on motion of Mr. Burke, opened by the Secretary, and referred to the committee of the whole.
