A Times special from Belgrade reports that 20,000 Russians had crossed into Serbia. The French, Italian and Austrian consuls general went to Orsova to ascertain whether the report was true. No confirmation has come, so it is probably false.

Orders have been received at the Devonport dock yard to complete repairs on the four turret steamships Oryz, Hydra, Gorgon and Hecate, each carrying four guns, and the torpedo boat destroyer Gorgon, carrying twenty-eight guns. Three composite gun vessels are building here, and two others in private yards are being prepared for commission.

A Rector telegraphed from Athens announcing the ministry have submitted to the Chamber of Deputies bills authorizing a general levy and reorganization of the forces. Additional taxation and the abolition of the old debt of Greece are also proposed.
