

Mr. Beckwith, United States district attorney, took his place in the ranks for the purpose of depositing his ballot, but when his name and the number of his registration paper was called the commissioners informed him that his name had been erased from the registration list, and therefore he could not vote. This was such an evident error that Mr. Beckwith found little trouble in satisfying the proper officers that he had been wronged. After a short delay he succeeded in having his name replaced, and then deposited his ballot. Mr. Beckwith was not the only Republican victim to registration mistakes.

Powder and Lead on Carondelet Street.—Between two and three o'clock last evening Carondelet street, near Common, was aroused from its peace of calm and order by the cheerful notes of a couple of revolvers. Somebody had dealt Donald McKillop a stunning blow on his head, and he was turned to seek his antagonist he saw John B. Brie, and at once concluded that that gentleman was his assailant. On the instant McKillop put himself on the offensive, and, as he says, drew his revolver and fired at Brie five times, three of the bullets taking effect in his body and two of them barely missing the mark. After the second fire Brie fell to the banquet, stumbling against a projecting flagstone. One of McKillop's bullets also prostrated him, but he arose both times and did his best to shoot at his antagonist, but he appeared unafraid and shot wild; at least he did not wound McKillop. Both pistols being empty, hostilities ceased, and Colonel Leas, who was near the scene before the battle was over, arrested McKillop and sent him to prison. Indeed, Colonel Leas made an attempt to stop the fight while the belligerents were firing, placing himself in a position where Brie's bullets were likely to strike him. Brie, wounded three times, two wounds in his right thigh, was sent to the Charity Hospital, and after a close examination the surgeon concluded that the case was far from a hopeless one.

It is reported that the animosity existing between the men was first caused by McKillop writing a note to Mr. H. F. Joubert, about two weeks ago, asserting that Brie was not a citizen of this country, which fact was made known to Brie. Another remark is that when Brie was dealing in live stock he promised McKillop a certain sum of money if he succeeded in making a large sale of mules for him on specified conditions, but it is alleged that the sale was not properly effected and that no money was paid for the transaction.

Mr. Brie was a candidate on the Republican ticket for clerk of the First District Court, and at present owns the saloon at the corner of Baronne and Poydras streets.
