mixture that appear on the table in the winter. What there is, however, is well cooked, and is of a quality that makes up for deficiencies in style.

In most country houses a dining room is comfortably but not expensively furnished, the floor is covered with rug, and the walls are decorated with pictures and a few pictures are on the walls, and cheap, inexpensive but dainty curtains bow back and forth at the windows.
