ADVICES FROM SAN DOMINGO, dated September 22, state that circumstances have continued to favor General Henriques, commander of the Government forces at Maco, and that the rebel generals Moya and Benito were encamped with their followers at El Mango, where they would soon be attacked.

The populace of Delhi, India, is reported much excited. Party feeling between Hindus and Mohammedans is intensely aroused. Angry crowds continue to assemble in the streets. The whole agitation is caused by the finding during the early part of the month of a Mohammedan murdered in the Queen's gardens.

A STATEMENT prepared at the Treasury Department shows that there are now outstanding \$60,139,952 in standard silver dollars, being the largest amount of that coin in circulation since its issue began. A coin decline, however, is now expected as a result of the issue of the more convenient silver certificates.

At a recent meeting of the English holders of Pennsylvania railroad securities in London a resolution was adopted declaring the time had come to distribute among shareholders a portion of the company's reserve funds; declaring also that the directors of the company ought to agree upon some definite principle for the division of the future net earnings of the road.

M. MEISSONIER has left Paris for Venice to complete on the spot a large canvas he commenced last year in which nearly three hundred figures are represented. He paints every morning in St. Mark's, sitting astride on a chair at the foot of the pillar, with his box of colors on the floor beside him. The painting will represent a corner of the chapel of the Madonna, one of the artistic gems of the famous basilica.

The note presented to the Bulgarian Government by General Karibiers before his departure from Sofia, was in effect as follows: "The Imperial Government desires to release all persons arrested in connection with the deposition of Prince Alexander. It also desires that the elections be postponed until November. The consequences of a refusal to comply with Russia's wishes will fall upon those actually governing Bulgaria."

The official journal of Strasburg, noticing the formation of a ladies' committee at Metz to attend the graves of French soldiers who were killed there in 1870, declares that the committee is useless, the German Government having charged itself with the careful attendance of the graves under article sixteen of the Frankfurt treaty; further, that if the committee makes the matter an occasion for a political demonstration, they will not be tolerated.

GOVERNOR BROWN, of the Seminoles, at Tuleague, I. T., has about completed arrangements to have a per capita payment of about ten or fifteen dollars to his people. The reason for this, the Governor says, the Seminoles have almost made a total failure of crops, the drought of this summer ruining them, and that his people would be bound to suffer if some kind of an arrangement could not be made to help bring them the necessities of life.

A COUPLE of divers, with full diving suits and utensils, arrived in Burlington, Vt., recently and proceeded to the vicinity of Valcour Island, where they will attempt to raise a boat which is supposed to contain a quantity of gold. The theory is that a British craft, which was sunk during the times of 1812, when the military operations between the British and Americans were going on. The boat, which lies in only about twenty feet of water, has always been plainly visible in low water, and men have frequently dived and recovered cannon balls and relics from its decks, while in swimming, as the stories say. A Brandon man is the prime mover in the affair, and his two divers are from Boston.

This Illinois Board of Railroad and Warehouse Commissioners were in session at Chicago recently on the matter of railroad discrimination regarding freight rates. SENTENCED.

The Anarchists Contend: Their Speeches and are Sentenced According to the Verdict.

CHICAGO, Oct. 11.—Hundreds of people would this year toward the execution of Anarchist Parsons, with the exception of hearing the death sentence pronounced. Parsons resumed his speech as soon as court was opened. He created something of a sensation by declaring in a very calm and impressive manner that he had no hostile feeling toward the law which had just sentenced him to death. He created such destruction at the Haymarket was thrown by an agent of the New York capitalists and monopolists, who sent the man out here to take this means of breaking the eight-hour movement.

As proof of his assertion that there was a great conspiracy on the part of capital against labor, Parsons quoted the expression of the Hon. Charles P. Clark, United States Senator, in which he declared, among the following theory: There is a conspiracy to increase the value of the dollar, to get possession of it, and to control the world over. Parsons claimed that he and his colleagues were the victims of this conspiracy.

When he finished speaking from his notes, Parsons entered upon an account of what he knew about the Haymarket killing and his movements immediately after the explosion in the room when he surrendered himself in court.

He had spoken continuously five hours and forty minutes, and he sank into his seat exhausted.
