The late Storm on Hawaii.

From advices from Waimea and Kohala we learn that the storm of the 9th inst. was most severe in those districts, particularly in Kohala. We cannot better describe the fury of the storm at the latter place than by publishing the graphic accounts of it, given by Mr. D. D. Baldwin, manager of the plantation, and Rev. Mr. Bond, a resident at that place for over thirty years, to Hon. S. N. Castle, Treasurer of the Kohala Sugar Company.

and trees. We had as usual commenced our morning gridding, when the rain drove in under our boilers, extinguished our fires and drenched our whole mill building with a deluge of water; and it was with the utmost difficulty that our sugar on hand in kags and the bins were saved. Our loss in hand was considerable. The fall of our steam chimney of course prevents gridding now, but we are putting up a new one, and shall commence again next week.

The storm commenced about 6 A. M., and ceased at 10 A. M. Its greatest fury was from 9 to 9 1/2, torrents of rain came with it. The district is swept as with the beam of destruction. About 150 houses were blown down, trees in ravines torn up like wisps of grass, care stripped and torn, as never before, and even the grass forced down and made to cleave to the earth. The main houses on the plantation, though flooded, remain in position. Cooper's shop and several of the people's houses moved from 2 to 10 feet off their foundations. Steam chimney blown down, also half a mile of the fence, &c. The damage is variously estimated at from \$30,000 to \$100,000. I should say \$50,000 would be a fair estimate. In our garden there is scarcely a whole tree of any kind remaining. A mango tree 15 inches in diameter was snapped as a pipe stem, just above the surface of the ground. Old solid kukui trees which had stood the storms of a score of years were torn up and pitched about like chaff. Dr. Wright's mill and sugar house, the trash and dwelling house for manager, or head man, were all strewn over the ground. We were and are most thankful that the storm came in the day time, and also that it was so limited in its duration. These are the large drops of mercy mingled in the cup.

The number of houses destroyed at Waipio, we understand to have been 27. At Waimea but little damage was done except to the road between that place and Kawaihine which, we are informed, was seriously damaged in places, by the torrents of water.

Other portions of Hawaii seem to have escaped the injurious effects of the storm. At Hilo a strong wind blew during the day, and in the Districts of Kona and Kau a vast amount of rain fell without wind. The storm seems, so far as we can judge, to have been a cyclone, moving from S. E. to N. W., its most destructive force having been felt in a diameter of from 150 to 200 miles. As the China steamer from San Francisco would probably have been somewhere to the N. W. of these Islands at the time of the storm, it is not improbable that we may hear of her encountering the gale.

One of the modes of treating the wild cattle on Hawaii has been, when driven in to the slaughter pen, to hamstring them in order to make it impossible for the animals to get away until it was convenient to kill them. It has not been infrequent that the poor beasts thus disabled and tortured have been left over night or all day, crippled and suffering intensely, awaiting the butchers knife. On his recent visit to Hawaii, the Minister of Interior becoming cognizant of this brutality, called the attention of the police authorities to the fact. Several parties engaged in the business were recently arrested and brought before Judge Spencer, at Waimea, charged under Section 1, Chapter 24 of the Penal Code, which reads as follows:

1. Whoever shall cruelly beat, torment, or inflict suffering upon any horse, ox, mule, or other animal belonging to another, shall be punished by imprisonment at hard labor not more than three months, or by fine not exceeding one hundred dollars. If the animal belong to the offender, he shall be punished by a fine of five dollars for the first offense, and an additional five dollars for every subsequent offense, and in default of the payment of any such fine shall be imprisoned at hard labor not exceeding thirty days.

The parties arrested plead that as the custom of hamstringing cattle had been practiced for many years, they supposed there was no harm in doing so. They were fined one dollar each, and were assured that any further violation of the Statute would be prosecuted to the extent of the law.

There can be no doubt that the means used in procuring laborers for the above countries have been, to a great extent, illegal and improper, and that the attempted suppression of the trade is well worthy that great nation which has ever been foremost in alleviating the sufferings of the wronged and oppressed. It is probable, however, that among those who have been the loudest in denouncing the business, a much more desperate state of affairs has existed in their imaginations than has existed in fact. One thing has always been incomprehensible to us in this matter of kidnapping natives, and that is, how a vessel, a schooner perhaps of eighty or a hundred tons, manned by a crew of ten or fifteen men can land at one of these islands and carry off from one to four hundred (in many cases warlike) natives by force! This view of the case seems to us quite improbable if not impossible, though we have no doubt that misrepresentation and fraud are used in inducing the people to leave their homes, and persuading the chiefs to permit them to depart.

Death of L. L. Torbert.

It is seldom that we are called upon to record a death in this community, which might so appropriately be termed a public loss, as that of Linton L. Torbert, which occurred at his residence in this city on Thursday afternoon last. Cut down when he had just reached the prime of life, full of vigor and energy, with flattering promises of future usefulness and success in the battle of life, surrounded by a happy family and troops of friends—his death indeed creates a void in the community. He had resided on the islands some twenty-six years, a large portion of the time on Maui, where he was one of the pioneers in the business of sugar planting, and was noted for his enterprise and industry. He was at one time owner of the land which now constitutes the Maieko plantation, then a cattle ranch, upon which he erected no less than sixteen miles of stone wall, much of which can be seen to this day. In the various enterprises in which he has since engaged, Mr. Torbert has displayed the same characteristics of indomitable energy, and has invariably borne a high character for probity and moral principle. He was about 55 years of age at the time of his decease, and was a native of Newton, Bucks County, Pa.

Yesterday, the flags on the shipping and generally throughout the city were displayed at half-mast in respect to his memory. The funeral, which took place yesterday afternoon, was very numerously attended by the residents, on foot and in carriages. Mr. Torbert was a member in high standing of the Order of Free Masons, which body took charge of the funeral ceremonies. The procession was as follows: First the Order of Good Templars (Mr. Torbert was an active member of Utuana Temple Lodge, No. 11); the Blue Lodge of Masons; Honolulu Royal Arch Masons; the Commandery of Knights Templar; the Hearse; Mourners and citizens generally in carriages. At the grave the beautiful and impressive service of Masonic Knighthood was read by Prelate A. McIntosh, and the last sad tribute of respect having been thus dutifully paid, the casket of the body closed over that which was mortal of our true friend and brother—Advertiser, Aug. 19.

CORRESPONDENCE.

MAKAWAO, Maui, August 16, 1871. Editor Hawaiian Gazette—Dear Sir: Since early in July, 1870, we at Makawao and vicinity, have been abundantly supplied with water from "the river of God," so full of this indispensable element for the comfort of man and beast. Some of the time during the past year, it seemed to us that we were having rather too much of a good thing, especially about the first week of November, when we came the nearest to having a flood of any time since my residence at Makawao. Of this I gave you some account under date of Nov. 7th, 1870. During the past winter and spring, our rains were timely and sufficiently copious to keep our pastures in good order for grazing purposes, and our one-field in a growing state. In some parts of Kula, at and around Keokea, so abundant were the rains that a good crop of corn was raised, which might have been greatly increased but for the scarcity of labor—the people of Kula having rapidly decreased of late years. A fine crop of Irish potatoes is now being gathered at Keokea, I am told. A barrel of fine ones as I have ever seen at the Islands was brought me from that place quite recently. Not a kernel of wheat nor a handful of oats has been committed to the earth in all Kula. I see no prospect of a revival of this branch of industry among us. We must look abroad for the supply of our wants in the matter of bread stuffs. I see no remedy for this unless a supply of laborers shall be introduced from some other country.

To resume the subject of rain at Makawao: As the heat of summer increased, the rains decreased, and though we had occasional showers all along, yet we began to feel the need of a thorough soaking rain, especially as the trade winds were unusually strong during the whole of the month of June, and these neutralized almost entirely the benefit of our frequent showers. We looked forward to the month of July for the usual rains of that month, and though these were not entirely withheld, they were much lighter than usual, and as August came in bright and pleasant, we certainly had some fears that our climate would be very low, not to say dry, ere our winter rains could be expected to afford us relief. Wednesday morning, August 9th, on awaking, I found it was raining smartly, the wind blowing from the East, though not violently, at sunrise. I supposed it was a Naula-shower, which often visits Kula, attended uniformly with copious rains, but commonly of short duration. But as the wind continued to strengthen as the day advanced, I asked a native the name of this wind, which began to excite our fears for the safety of our dwelling. He said it is "the Kin, blowing directly from Kahalaekala, a wind which prostrates houses." On turning to our Hawaiian Lexicographer, I find the following definition: "The name of a strong wind at Honouliuli, Maui, occasioned by the trades breaking over the mountains." I had often heard of this wind, but till now I had not experienced its power. It was fearful. Our house is an old one, and my fears were that it would yield to the power of the blasts which, from morning till near noon, were beating upon it. But we were graciously preserved. The preservation I attribute, under God, to the fact that the building, which is a long and wide one, is also low, and besides among fig trees of gigantic growth. The storm seemed to spend its force upon these trees, breaking some of them off a few feet from the ground; twisting of large limbs, and covering the ground with half-grown fruit, leaves and twigs. The rain was continuous during all the day, and towards noon the voice of thunder was heard, awakening the hope that the storm had reached its height and would soon abate. It did so, but the very last puff of the blast lifted from its foundation the large house lately built for the Haleakala School, inflicting upon it considerable injury. The milk and butter house of Mr. H. Rogers was totally destroyed, and our native meeting-house was somewhat injured. Some of the out-houses on the East Maui Plantation, also at Grove Ranch, were thrown down or unroofed, and otherwise injured. Some three or four framed and boarded school-houses at Makawao and Hamakua were blown to pieces, leaving the Hawaiian children very hemphasa, as they say. They were probably put up hastily and slightly. The fact is, so long a time has intervened since we have experienced a heavy storm of wind, that all seemed to have forgotten that we had ought to fear from this element. I hope we shall learn a lesson from what we have now suffered from this fearful storm.

I learn that this wind scarcely reached Kahalaekala, or the Haiku Station; and that it was slight from Waikupo to Waieho. But our friends and neighbors at Uluhakauna suffered greatly. The storm there was terrible—most destructive to sugar-cane, walls, buildings, and especially to trees. Capt.
