We have to note the arrival of the bark Oahu, from the Hawaiian Islands, from Boston, with merchandise to C. Brewer & Co., the Am. bark Arctica, from Nantucket, with goods from the West, and the bark Hong Kong, 15 days from San Francisco, bound to Yokohama, by which we have San Francisco dates up to the 27th ult. We learn that the D. C. Murray arrived here in 20 days; and was advertised to leave on the 20th, and may be looked for on the 15th.

The arrival of vessels, reported elsewhere, show that vessels are not much delayed. Other news has been fairly attended, and goods have brought fair prices.

The report from the whaling fleet, received by the Hongkong, will be found under another head.

The German clipper bark Hongkong, arrived yesterday on route for Yokohama. Left San Francisco, Sept 27th, and expected favorable wind the entire passage, which was made in 23 days. Reports the bark D.C. Murray having arrived over on the 20th ult., 20 days hence, and was to leave on the 20th with the mail.

The Hawaiian clipper bark K.W. Wylie sailed on Saturday, for the Oahu Islands, to load for Europe. The Wylie has always made extraordinary fast passages out, with the exception of last year; three of her passages having been made in less than 120 days.

HABES CORPUS.—By the Kamehameha V., which vessel arrived here on Wednesday last week from Tahiti, came as passengers some thirty Chinese. It seems that their employer at Tahiti permitted them to leave his employ and take passage in the vessel, provided they could themselves, from their savings, pay their passage to the United States, to the amount of \$100 each, or make arrangements to pay their passage on their arrival here. Not having, in most cases, sufficient money to pay their passage, the captain of the vessel agreed with them to bring them to Honolulu, with the understanding that they should pay him or the owners of the vessel upon arrival. The vessel arrived here on Wednesday last week, and the captain, Mr. J. H. Barrett, and twenty members of Chinese have obtained passage from Tahiti to this place on precisely the same conditions as those who came by the Kamehameha, and in every instance but the one, have promptly made arrangements to pay their passage.
