

CONGRESS LIBERAL WITH LEGISLATION AFFECTING HAWAII

More Measures Passed For Territory Than By Any Similar Body Since Annexation

WALKER (Mail Special to The Advertiser) WASHINGTON, July 14.—With Senate acceptance this week of the conference report on the rivers and harbors bill, goodly sums are assured for improvements in Hawaii. The bill carries an item of \$100,000 for Honolulu harbor. These probably will be a balance from funds now available for completing the old Honolulu harbor project, and it is hoped to use this balance by authority of congress, which can easily be obtained, for the new Kalia channel project. This measure also helps along toward an additional quarter-million dollars for that improvement.

The rivers and harbors law, which probably will have been signed by President Wilson before this letter reaches Honolulu, carries \$250,000 for the Kahului west breakwater. The appropriation was approved in spite of the rule adopted by the house committee not to include any new projects, and stands as a splendid testimonial to the efficient work here of George M. K. McClellan. Indeed, the senate seems to have put this appropriation in the bill largely out of deference to Mr. McClellan, and the house conferees assented to the item for the same reason. In a kindred connection congress has voted \$90,000 for a lighthouse station at Honolulu.

Record Legislation for Hawaii

These are some of the larger items in the way of appropriations, but it is becoming apparent that this Democratic congress at its first session has been doing very great deals for Hawaii. Probably more legislation has been passed for the Territory than by any other congress since annexation. In the category is an act urged by the Honolulu chamber of commerce transferring to the county treasuries the payments made by public service corporations of a per cent of their gross receipts. Congress has likewise done much in enlarging the powers of the public utilities commission over public service corporations. The board of harbor commissioners has been granted larger powers. Closely related to these measures is a number of bills, now law, confirming original or extending existing franchises to public utility corporations. Congress has confirmed the Kauai electric franchise and extended the operative areas of the Island Electric Company of Maui, the Hawaiian Electric and the Honolulu Gas Company in Oahu. This legislation authorizes the public utilities commission to order extensions of service under reasonable conditions. The house has also passed a gas franchise bill for Hilo and it is now before the senate committee on Pacific islands and Porto Rico. The house has favorably reported a bill to extend the Hilo street railway franchise.

Pension Bill May Pass

The bill to provide retirement pay for Judge Dale is on the house calendar and has some chances of enactment at this session of congress.

The army appropriation bill, as now before the senate, carries \$10,000 to provide for surveys for the military roads on the island of Oahu. If these surveys for location of roads and estimates of cost had been prepared by the military department of Hawaii, an appropriation might have been forthcoming for that work at this session.
