HAWK-EYE CHANGES HANDS.

The Waite and Davidson Families Buy it of C. E. Perkins Estate.

Burlington Saturday Evening Post: The Burlington daily Hawk-Eye is in the possession of new owners. The title has been transferred from the old company, of which the C. E. Perkins estate was the owner, to a new company, the president of which is Mr. J. L. Waite, postmaster of Burlington. Associated with Mr. Waite in the new ownership of the paper are his son Clay M. Waite, for some years past the business manager of the Hawk-Eye, and W. H. Davidson, managing editor of the paper and son-in-law of Mr. Waite. The change, which is of recent date, was effected so quietly, that but few persons in the community are aware of it. Even the employees of the paper working in the building are not aware that there has been a change in their employers. It is understood that there is to be no radical departure from the conservative lines along which the paper has been conducted since Mr. Waite took charge as editor in chief twenty years ago, and that all of the old employees of the paper will continue on as heretofore.

The Hawk-Eye has had a notable history and is one of the most widely known newspapers in the United States. Its inception dates back to the Indian occupancy of southeastern Iowa. Chief Black Hawk once visited at the Hawk-Eye office and received a personal in the next issue of the paper. It has had a succession of able and brilliant men at its helm. It is but justice to the present administration of the Hawk-Eye to say that it is a better newspaper today than ever before in its history. Among the men whose talents have served to illumine the pages of the fine old Hawk-Eye there are recalled such names as Dr. Beardsley, George Frazer, J. G. Edwards, Frank Hutton, Robert J. Burdette, John W. Burdette, E. P. Heizer, Jason E. Calkins. Mr. Waite, present editor in chief, dates his association with the paper to the years preceding the civil war. While

NEW PLAN TO GET STATISTICS

Present System Considered Inefficient, Would Have all Births Reported to State Department.

DES MOINES, Iowa, Dec. 17.—Here will be a radical change in the method of securing vital statistics in Iowa if the recommendations of Louis A. Thomas, secretary of the state board of health and of the state vital statistical department, are adopted by the coming legislature. Mr. Thomas brands the present method of securing data concerning births as totally inefficient. It is now left for assessors to discover once a year how many children are born. Mr. Thomas would have a law requiring the father of every new-born child, under penalty for violation, to report the birth to city authorities who in turn would report all births to the state statistical department. Concerning the subject Mr. Thomas says:

Provide Penalty.
"The state required that mortgages, title deeds and like instruments shall be recorded in the office of the county recorder and a small fee paid for such record. A similar requirement concerning births with sufficient penalties for failure to make the record within a specified time, presents the most favorable prospects for obtaining accurate records and statistics."
"The department of vital statistics now receives an annual appropriation of \$2,000 per year. With an additional appropriation of \$3,000 to cover extra clerical assistance and printing, and the enactment of a law embodying the suggestions it would be possible for Iowa to establish and maintain a system of statistics equal in accuracy and value to that of any country."

To Examine Nurses.
Another important recommendation of the secretary is: "As all graduate nurses who were residents of Iowa on the 12th day of March, 1907, have had ample opportunity to obtain certification, and as indefinite continuance of this privilege is likely to cause much confusion and unnecessary misunderstanding, it is suggested that this provision be repealed after Jan. 1, 1909, and thereafter all graduate nurses, be required to pass the state examination in order to obtain a certificate of registration."
He further recommends that additional chapters be added to the maternity hospital law requiring every hospital to have at least one registered nurse and also that each patient be given a separate room containing not less than 1,000 cubic feet of air

space, and having at least one outside window not less than 4 feet 6 inches by 2 feet 6 inches, or its equivalent.

FIFTY WITNESSES IN DAMAGE SUIT

Want Damages for Being Restrained During Construction of Corn Produce Plant.

CHICAGO, Dec. 17.—The federal authorities today summoned fifty witnesses to appear before the grand jury to testify regarding the alleged violations of the peonage laws during the construction of the \$15,000,000 plant for Corn Produce and Refining Company at Argo, Illinois. It is charged the men were kept behind a fifteen foot stockade topped with spikes, guarded by armed sentinels under command of Barney Flynn, a strike breaker. The plant was being built by the Lake Construction Company.

THE SUBJECT OF HAZING

What President James of the University of Illinois Had to Say of the Matter.

In an address to the students of the Illinois University some time ago, President James had the following to say regarding the practice of hazing: "There should be no misunderstanding on the part of the student body or the general public as to the attitude of the authorities of the University of Illinois on the subject of hazing. It is a rule of the board of trustees that students found guilty of hazing shall be dismissed from the University. Since this rule went into effect, all students who have been clearly proven guilty of hazing have been dismissed. Hazing is a violation of good manners and of the right of individual liberty. It is provocative of public disorder. Public opinion throughout the state has very properly set its seal of condemnation upon it. On all counts it must be put under the ban of the University. In its milder forms it is a nonsensical and almost idiotic form of amusement, unworthy of the support or favor of any sensible university student. It was looked upon as a comparatively slight offense perhaps twenty years ago in small institutions. It is today altogether unworthy of the traditions and reputations of a national institution such as this has become. In its coarser forms hazing is a vulgar, brutal, always demoralizing and sometimes dangerous form of sport which the University cannot countenance or tolerate. It naturally leads to reprisals and may thus become a source of serious disorder within and without the University. In its worst forms, which fortunately have not prevailed here, it may, not inaptly, be compared with night-riding, white capping and other similar forms of outrageous interference with private and public rights. Surely there are reasons enough not only to forbid its existence at the University, but to use every legitimate means to stamp it out. All loyal and law abiding students are especially requested to cooperate with the authorities in putting an absolute end to this custom which in addition to the evil it does within the University brings dishonor upon the fair name of our alma mater through the state and country and naturally begets a prejudice against us which influences unfavorably the prosperity of the institution."
