## MAHMOUT WILL THROW THEM ALL

Big Wrestler Who Will Make Appearance in Keokuk Friday Night Will Have Some Strong Opposition.

## A STANDING CHALLENGE

The World Can Meet Him at Grand Opera House Here—Tom Walsh is One of Strong Men to Dispute Honors.

Yussif Mahmout is the only wrestler in the world who appears on the mat bare-footed and when he goes against a coterie of stars at the Grand opera house in this city Friday night he will be minus any semblance of footwear such as other big wrestlers of the world don in their grueling bouts.

Mahmout, who has a good claim to the world's championship—a claim that is only disputed by a few—acknowledges that he will be up against it in his match here because of his agreement to clamp down the shoulders of two husky tusslers three times each in an hour. One of these big boys is Tom Walsh of Omaha, who has been dogging the trail of the champs for many months, and only is to be rewarded with a go. Walsh, according to "Farmer" Burns, not only one of the greatest judges of wrestlers in the world, but formerly a top-notch himself, is a comer and his bout with Mahmout is expected to prove a stepping stone to a brilliant career on the pad. Walsh has all the ear marks of a coming champ. All he needs is experience. Following his match with Mahmout in Keokuk, Walsh will be booked with some of the best men in the country.

A second husky who is to be sent against the foreigner is the "Kansas Jayhawker." He is an exponent of the game who is now not entirely unknown in the wrestling world. The Kansas wrestler is fast and has the weight that will make him a worthy opponent of big Mahmout.

Promoter John Hall expects a crowded house and the match should be well patronized by Keokuk bugs and those from the surrounding towns. The promoter has secured one of the husky foreigners at work on the water power dam for a whirl. It is said he is not a novice at the game, and is a clever man in the 175 class.

The Friday night match is the first Keokuk has had since the appearance of Frank Gotch, who was then the undisputed champion.


