

WILL SELL DRINK TOMORROW TO TEST MULET LAW REPEAL

Possibility That the Supreme Court Might Not Assume Original Jurisdiction, Alters Procedure.

TO FILE INFORMATION

Sheriff Scott Will Arrest Nickel and County Attorney Will File Charge in Justice Court.

STEPS IN TEST CASE.

Phil Nickel to sell drink to Fred Krieger at No. 2 South Water street, 10 o'clock.

Sheriff John Scott will arrest Nickel. Information against him charging illegal sale will be filed by County Attorney E. W. McManis.

Hearing will be held before Justice James S. Burrows.

Petition for habeas corpus writ will be filed in superior court.

Briefs in case submitted to supreme court as soon as possible after hearing in justice court.

Because of the possibility that the Iowa supreme court might not assume original jurisdiction in the test of the repeal of the mulet law, which will be made by Phil Nickel, here tomorrow, a change in procedure in the case was decided, after a conference on Friday between George Cosson, attorney general of the state of Iowa, and Frank M. Bullinger, attorney for Phil Nickel.

The sale will be made on Monday morning at 10 o'clock by Phil Nickel to Fred J. Krieger. A ten cent bottle of Leisy's beer will be sold in the building at No. 2 South Water street.

John C. Scott, sheriff of Lee county, will arrest Mr. Nickel when he sells the drink. The information against Nickel will be filed by E. W. McManis, county attorney, who will look after the state's side of the case in the place of the attorney general, who will not come to Keokuk.

Information Before Burrows.

The information will be filed in the court of James S. Burrows, justice of the peace, and preliminary examination will be held before Justice Burrows. All documents showing that Mr. Nickel complied with the mulet law will be introduced into the hearing.

These will include the government stamp tax and the exhibit showing that tender of the \$400 for mulet tax was made, also the license which is granted by the city of Keokuk.

If Justice Burrows finds Nickel guilty of violating the law, and it is presumed that he will, then he will be bound over to await the action of the grand jury. Minutes of the testimony will be taken in the hearing by Charles J. Smith, official reporter for the first district.

Ask for Habeas Corpus Writ.

The time for hearing the writ will be fixed according to the law.

Ready for Supreme Court.

In the meantime the briefs and arguments for the submission of the case to the supreme court will be prepared.

Mr. Cosson will ask the court to advance the case on its calendar, and probably this will be done. If it is, the hearing will be held six months sooner than otherwise could be.

Yesterday morning attorney for Nickel had conversation with attorneys in the Davenport case, asking him to postpone the test case here, until a conference with them could be held.

It was decided by Mr. Nickel and his attorney to go ahead with the case as originally planned.

Case Attracts Attention.

The test case at Keokuk attracted considerable attention since it was first talked of, and it is probable that there will be a crowd around the saloon which will be opened for the purpose of selling the drink.

It was first decided that original jurisdiction should be vested in the supreme court, but there was a possibility that the high court would not assume this, and consequently it was thought best to start the case in a lower court.

In this way it is believed that a prompt decision will be received.

If the law is considered to have been properly repealed, then Mr. Nickel will be found guilty of law violation.

If the high court should give an adverse ruling on the law, it is probable that a special session of legislature will be called to correct the trouble and make the repeal legal.

Injunction at Davenport.

The Davenport Democrat tells in the following of the signing of the injunction there.

While a crowd of about 100 curious spectators was anxiously waiting for the hearing on the temporary injunction against the three Davenport saloon men, who opened up their saloons for the purpose of starting a test case, to come up, Judge M. F. Donegan signed an order granting the injunction in an adjoining chamber.

None of the three defendants, John Hill, John Schnack or J. J. Naven, or Attorney Louis Block, for the saloon men, was present when the order was signed.

An agreement had previously been made between the attorneys for the liquor men and County Attorney Jensen to allow the court to grant the temporary injunction. The fight will be staged when the matter comes up for a final hearing, which will probably be some time within the next few weeks.

The order was merely handed to the court and was signed, the entire matter only taking a few seconds.

CITY WATER PURE, ANALYSIS PROVES

State Chemist Can Find no Gas Forming Bacteria, Which Means No Sewage is Present.

TO MAKE MORE TESTS

Additional tests of the water will be made at different times in order to make sure that the quality of the water is being maintained.

Following the demand made by Mayor Moorhead for safe water, the water company sent an expert here from St. Louis to see what could be done in the way of assuring pure water for the city.

REVENUE STAMPS STILL NECESSARY

Congress Re-enacted War Tax and Public is Reminded That the Stamps Are Still Needed on Various Articles.

LETTER FROM MURPHY

Revenue Collector for Iowa Says That Unless Tax is Paid This Month, It Will be Doubled.

DUBUQUE, Jan. 7.—Hundreds of inquiries received at the office of the collector of internal revenue for Iowa, indicate general ignorance of the fact that congress, just before adjournment for the holiday recess, re-enacted the war revenue emergency act in its entirety for one year dating from January 1, 1916.

This is the law which requires stamp taxes on leases, notes, etc., and on cosmetics and perfumes; and imposes special taxes on bankers, brokers, pawn-brokers, commercial dealers and manufacturers of cigars and tobacco.

The returns of individuals and corporations must be made before March 1 to avoid heavy penalties.






