

THE GREAT STRIKE

ANOTHER DAY OF THE SHORT LINE TROUBLE.

A Party of the Supposed Strikers Make a Raid on the Working Force. The Police Called Out, and the Rioters Quietly Dispersed—What Assistant Superintendent Case Has to Say of the Trouble—Statements of Strikers.

The P. P. local department is peculiarly unhappy in its utterances. Having lost the fact exclusively reported in the Globe of Tuesday of the strike of three hundred men on the Short Line, Monday noon, that paper yesterday declared there was no strike, but a few lazy men had quit work, etc.

The facts are these. There is a strike on the short line, and the consequence is that over two hundred men quit work and refuse to do more till the company consent to pay them the advance they demand. The wages that they have been receiving are the paltry sum of \$1.25 per day, and we are obliged to pay \$4 per week for board.

With this on hand, mostly new men, and some old ones, the work was begun yesterday morning at the usual hour, 6 o'clock. Mr. Graham had charge of the party, and under him in charge of the gangs, were Messrs. Kenner, Reagen, and others.

There was no strike; it was simply a refusal of a lot of lazy fellows to work, some of them only having been on only half a day. Again we are compelled to note a barefaced falsehood; for we cannot give any other name, or a more appropriate one.

Mr. Graham also withdrew his party, and the rest of the gang followed suit. A consultation of houses followed, and a message was dispatched to Assistant Superintendent Case and Roadmaster Moll.
