Lorne and Louise sail for England Oct. 26. Victor Hugo is to be banquetted at Geneva. Last week 9,053 emigrants were launched at Castle Garden. Quarantine will be discontinued at New Orleans on Saturday. The Spanish princes are not mentioned in Count de Chambord will. Frank Kieree fatally shot his wife at Foleyham, Pa. yesterday. Buckwheat and tobacco in the east suffered severely from the heat. Gnatamala is to build a \$12,000,000 railroad to the Atlantic coast. The Kansas City & Memphis railroad will be completed in ten days. Straw hats fare better than the corn, many of them survive the frost. Mrs. Phil. Speed of Louisville, a niece of the poet Keats, died Sept. 10. Col. Albert Wheatston, United States army died at San Francisco Thursday. The French police frustrated an attempt to kill King Alfonso while he was in Paris. The average cost of making custom collections is a little less than three per cent. Large numbers of Russian military officers are crossing the frontier into Bulgaria. Six new cases and one death at the Pensacola navy yard the past twenty-four hours. Green Bros. barrel factory and oil works were partially burned the other day. Loss \$50,000. The great council of Redmen have selected Springfield, Ill., for their next great council. Several earthquakes were felt at St. Thomas during some of the last days of August. Cretway's brother who was reported killed in the rebellion has turned up safe at Natal. A French aeronaut has succeeded in making a balloon trip from France to England. The iron workers and their employes in Pennsylvania were never so peaceable as now. The Count de Chambord though a crownless king left a royal fortune of \$15,000,000. The Atlantic and Pacific railroad offers another 150 miles of road for government inspection. Five business houses and the court house were burned at Greenfield, on yesterday. Loss \$12,000. At the Washington pension office June 30, there were 244,505 pending, of which 148,813 involve arrears. Gov. Sheldon informs the government that there is a reign of peace and good government in New Mexico. There have been floods in Texas, and trains have been greatly delayed, bridges swept away and sheep drowned. G. E. Fowler of south Framingham, was fatally shot one of two burglars breaking into his store on Thursday night. Three incendiaries who have burned \$100,000 worth of property in Philadelphia in two months have been arrested. John Schermerhorn, a well known New York lawyer, a member of the old Knickerbocker family is dead. He was 74 years old. The steamer "San Diego," built by the Roach's of Chester Pa., for the Pacific coast trade was launched at that place yesterday. Missouri colored men have appointed nine of their number to represent the state in the National colored convention at Louisville. A Milwaukee coroner's jury have held Nick Roderman for killing Peter Kahlebeck. He has made two confessions and the last one in writing. The riflemen sent James Gordon Bennett back \$2,500 of his donation to send them over to Wimbledon, they having had that surplus left over. The quarto centenary of the discovery of gold in Colorado was celebrated by the pioneers with a banquet at Jewel park, Denver the other day. The Canadian authorities know nothing of United States soldier's invading Canadian territory and kidnapping deserters from the American army. Two days of rain put a damper on the Oriole parade at Baltimore. It however came off Thursday night but was not up to former years in brilliancy. Five sixths of the rapid telegraph stockholders voted the other day to ratify the contract with the Merchants and Bankers telegraph company of New York. A Portland woman hit a man with an egg because he kissed his hand to her. Served him right says an exchange, next time he will know enough to kiss the woman. Wendell Phillips says he would hail the election of Gov. Butler as a vast stride towards relieving Massachusetts from the Republican incubus which is weighing upon her. A fire at Olympia, Wyoming, Thursday morning destroyed the surveyor general's office and other buildings. All the land records were burned. Loss \$60,000 and said to be incendiary. Ben Butler regards a second gubernatorial term as the gateway to the White House. An election would put him on the highway to that goal—a defeat would put him in "chuckery." Last week 682 foreign Mormon converts were landed at Castle Garden, and belonged to the laboring class. They were in charge of several Mormon elders, and are to be taken on direct to Utah. Evidence was adduced at the coroner's inquest on the Riverside disaster at New York, that the boiler had been leaking for two days and that the engineer had once blown up a tug by his carelessness. Government returns from nearly all the ports in the United States for the month of July show a shipment of less than fifty million and a balance of nearly five million against it. The most discouraging month's report of our foreign commerce for the year. The Prince of Wales is an extravagant dissolute spendthrift, and yet is the designated occupant of the British throne, as the successor of his mother, Queen Victoria, if he survives her. He now owes \$3,000,000 and all his gambling debts were paid only a few weeks ago. A beligerent female named Lucy Horton is threatening to massacre Secretary Folger if she is not appointed to a clerkship in the treasury department. Lucy is a fair pistol shot, having had some target

practice on a son of Senator Morgan, but why she should want to waste her ammunition on such a moribund duck as Folger is past finding out. Lucy should know that modern sportsmen never hunt anything but live game. In a bicycle race at Springfield, Ill., Wm. Woodside, the Irish bicycle champion, was violently thrown to the ground, breaking his left arm in two places. The National Pharmaceutical association, in session at Washington, has passed a resolution asking congress to appropriate \$25,000 for the introduction of foreign medicinal plants into this country, and for the care and propagation of home plants. At the inquest over the victims of the Long Island railroad disaster, the coroner decided there was no criminal neglect of the conductor of the Rockaway train, but that he was guilty of gross error in not stopping his train at Springfield junction. He decided that the rear brakeman of this train was guilty of culpable neglect, however, in not making proper signals. A North Carolina girl had her hand completely severed from the arm by an axe. The physician, not being in condition to amputate the arm above the wrist, replaced the hand, secured it with silver stitches and adhesive plaster, and having bound both arm and hand to a broad splint, ordered them to be kept warm with hot flannel cloth. The third day pulsation could be plainly felt in the hand, which had also changed its color. Says the physician in charge: "I removed the sutures on the fourteenth day, and afterward she carried the hand in a sling, and is now—three months after the accident—able to extend the fingers and grasp with nearly the usual strength. MINNESOTA NEWS. Faribault has contributed \$3,000 to the Rochester sufferers. New Ulm is to have a post of the Grand Army of the Republic. Zumbrota has sent over \$1,000 to the Rochester sufferers—Minnesota. At Northfield the citizens are building storm or cyclone coves for safety in time of storms. It is estimated that over 200 persons came out from St. Peter to witness the Villard demonstration. Quite a number of wheat stacks, in different localities have been struck by lightning and destroyed recently. The Owatonna Star says, Charles White of Akron has threshed his wheat and it averages 25 bushels to the acre. The cranberry crop this year is said to be immense. As high as 75 cents a bushel has been offered for picking. A farmer in Courland, Nicollet county threshed six acres of wheat that went a fraction over 32 bushels to the acre. The school house at Fremont corners, Winona county, was destroyed by fire the other night the work of an incendiary. The Rev. W. Cullen has been removed from the charge of the Kilkenny convention in Le Sueur county, by the bishop. The cause is not made public. Many hunters and many state papers report prairie chickens scarce this season. The insane slaughter of these fowls will result, and that right speedily in no more prairie chickens to hunt. The crop reports are growing better all the time. And now comes the report from Lake Prairie, Nicollet county, saying that John Aiton has threshed his wheat and most of it averaged 26 bushels to the acre. St. Charles Union: The thrasher is telling the tale of the crops, and it's an interesting one to the farmers. We hear that some pieces of wheat have yielded as twenty-five bushels per acre; some twenty-five; and others from sixteen to twenty. One field of 160 acres, belonging to C. W. Morgan, averaged 10 bushels. Eighty acres of the field, of the Lost Nation variety, yielded 18 bushels; the rest 22 bushels. With proper cleaning, a good deal of what raised in this vicinity will grade No. 1. The Royal Style of St. Paul. [Aitkin Age.] While there does not seem to be the same degree of propriety in the Minneapolis display, a city upon the line, that there was in that of St. Paul, the eastern terminus of this greatest of modern commercial thoroughfares, yet it was a very grand and imposing industrial exhibit, and albeit that it was called out by an insane jealousy of its sister city, did great credit to its enterprising people. That the entire Villard party were surprised and overwhelmed at the orations showered on them at every hand is not at all to be wondered at. When they originally determined to have a celebration at St. Paul, its eastern terminus, upon the completion of the Northern Pacific, as well as at the union of the two ends which occurs today, out in Montana, and consented to be guests of the mayor and common council of our state capital, probably not one in the entire party dreamed of its munificent hospitality at the grand scale upon which the celebration planned would be carried out. Never in the history of America was a city so gorgeously decorated, nor never did a city entertain her guests with the regal, princely fashion which St. Paul displayed on Monday. Go where you will on the line of circuitous and lengthy parade, or upon the side streets and it was one continuous flutter of flags and streamers, bright pennants, gay bunting, gorgeous arches, and floral and evergreen decorations. Amidst all these splendid adornments St. Paul received her illustrious guests, amid the booming of cannon and the crash of martial bands. She escorted them in the carriages of her most wealthy and distinguished citizens, preceded by the national and state troops, to reception headquarters, and nothing which could be thought of to conspire toward the comfort and happiness of her guests, or that could in any way manifest the highest esteem and respect felt for them, was allowed to pass unthought of. Well may each citizen of this state feel proud of their state capital and the way her citizens receive and entertain illustrious visitors. The splendid, manufacturing, mercantile and other features of trade, although outdone in point of numbers by the afternoon display at Minneapolis, will long be remembered by all who witnessed it, especially so by the party who were the guests of the occasion. All hail to St. Paul and the regal way she entertains. A Trick that was Fain. New York Sun. It is perhaps a novel sense of nearness to the main body of the Union, produced by the completion of the Northern Pacific Railroad, that impels a Washington Territory paper, the New Tacoma News, to call for an abandonment henceforth of the old-time methods of grouping the states. Certainly it is rather behind the age to describe the Eastern states as consisting of that half dozen known as New England, the Middle as embracing only New York, New Jersey, Pennsylvania, and Delaware, and the Western as beginning with Ohio and extending out to the Rocky Mountains. Such a nomenclature was no doubt existing in the early days of the republic, but an Ohio man who now presents himself in Colorado as coming from the great West may naturally be regarded there as having confused ideas about the points of the compass. Where the question is simply that of northern states as against southern, the old geographical lines still do very well; the distinctions based on latitude are fortified not only by historic events still fresh in memory, but by some marked differences in the products of the soil. With the lateral growth of the Union, however, the centre of population now finds itself in the neighborhood of Cincinnati; and it is rather queer, therefore, to see Ohio and Indiana still not recognized as coming within the pale of Middle states. Several efforts have been made to suggest grouping more in accordance with geographical facts. One of these, for example, divides the states into north Atlantic, Middle Atlantic, South Atlantic, Gulf, Central, and Pacific states. This classification is again in accuracy, and yet requires close study in order to be understood, since some of its details seemed forced and arbitrary; but what the New Tacoma News particularly insists upon is that the Territories must be included in any permanent grouping, because they are developed so fast into states that they might as well be taken into account now. It therefore proposes the following schedule: (1) Atlantic States—The six New England states, New York, New Jersey, Pennsylvania, Delaware, Maryland, Virginia, the two Carolinas, Georgia and Florida. (2) Gulf states—Alabama, Louisiana, and Texas. (3) Mississippi Valley states—Minnesota, Iowa, Wisconsin, Illinois, Dakota, Nebraska, Kansas, Missouri, Indian Territory, Arkansas, Mississippi, Tennessee, Kentucky, West Virginia, Ohio, Indiana, and Michigan. (4) Central states—Montana, Idaho, Wyoming, Nevada, Utah, Colorado, Arizona, and New Mexico. (5) Pacific states—California, Oregon, Washington, and Alaska. Still this arrangement, though original and ingenious, will hardly do. The acceptance of Louisiana and Alabama as good Gulf states, and the rejection at the same time of Mississippi, which lies between them, might possibly be excused; so perhaps might the lumping alike of West Virginia and Nebraska, of Ohio and Indiana Territory, among Mississippi Valley states; but the list given by the News of what would include all the eight Central states of the Union belongs rather to contemporary geography. The Origin of "Yankee Doodle" In the summer of 1775, the British army under command of Abercrombie lay encamped on the east bank of the Hudson river, a little south of the city of Albany, awaiting reinforcements of militia from the eastern states previous to marching on Ticonderoga during the month of June. These raw recruits poured into camp, each man armed differently from his neighbor. The armed presented such a spectacle as was never before equalled unless by the celebrated regiment of merry Jack Falstaff. Their entire appearance furnished great amusement to the British officers. One Dr. Shamburg an English surgeon possessed the tune of Yankee Doodle and arranged it to words, which were gravely dedicated to the new recruits. The joke took and the tune has come down to us. The following are the original words, as published in Farmer & Moore's "Historical Collections" in 1820. They differ considerably from those generally sung. Sewer on College avenue between St. Peter and Wabashaw streets. Sewer on College avenue from a point about 250 feet easterly of Rice street to St. Peter street with reference to assessment for same. Payne street from Minnehaha street to Maryland street, Minnehaha street from Seventh to Earl street and Forrest street from Seventh street to Beech street with reference to grading same. Third street from Maria avenue to Maple avenue, Canway street from Maria avenue to Maple street and Ravine street from Maria avenue to Maple street, also Hoffman avenue from McLean street to lot 17, block 16 suburban hills addition with reference to change of grade of same. Lord stating that his property is inaccessible, owing to a washout on the east end of St. John street in the Sixth ward, and asking that the street be put in proper condition. Referred to the Engineer. In the matter of the bids opened on the 15th inst for constructing sewers on Stillwater, St. Paul, DeBow, Somerset and Olmsted streets and the alley through blocks 3 and 4, Patterson's addition and which were adjourn'd to this day came up and after due consideration the same were upon motion rejected as being too high and the Clerk was directed to readvertise for bids. The City Attorney having submitted his opinion in the matter of the contract of J. G. Hinkel for sprinkling Seventh street, from the Seven corners to St. Peter street, it was ordered that the same be transmitted to the Council with the recommendation that the contract for sprinkling said street be annulled, Mr. J. G. Hinkel to take such steps in the matter as he may deem proper. The Clerk was directed to give the 1st notice for the 2nd re-assessment for grading Mackinac street from Dayton avenue to University avenue. The vote by which the order for grading Hudson avenue from Hoffman avenue to Cypress street was referred to the Engineer on the 15th inst., was upon motion reconsidered, and upon further motion it was ordered that the same be recalled and referred to the 5th ward member. In the matter of the order of the Council to Board for formal report on grading Payne avenue from Minnehaha street to Magnolia street and properly bridging its railroad crossing, the Board having viewed the same it was ordered referred to the Engineer, City Attorney and Alderman Van Slyke. In the matter of the order of Council to Board for formal report on the change of grade on Third street from Maria avenue to Maple street, Canway street from Maria avenue to Maple street, and Ravine street from Maria avenue to Maple street.
