April 18.—Flour is truly on the rampage, no concession from dealers' prices on the part of the very few holders of considerable quantities with a still further advance of \$5 per sack, which brings the market at these figures. Before 12 o'clock transfers were made at \$85 per sack, and some few dealers were asking a further advance of \$5 per sack.

April 19.—The flour market weakened under the excitement of "current reports" from some new speculators in the market, transfers of small lots being made at \$90 per sack.

April 20.—Our city is thrown into a state of excitement. Rumors of a bread riot are heard from all quarters.
