## SUSPECT IS CAUGHT

### CLOSE OF LONG SEARCH FOR ALLEGED FUGITIVE

## DAUGHTER ACCUSES FATHER

### Man Giving Name of Frank Meyer, Believed to Be J. C. Hunter, Arrested on Murder Charge at Billings.

(Special to Inter Mountain.) Anaconda, Nov. 4.—The arrest in Billings of the man giving his name as Frank Meyer, but believed to be J. C. Hunter, wanted for the alleged murder of his son-in-law, H. O. Walbridge, near the boundary line of Granite and Deer Lodge counties early during the spring of 1900, closes one of the most remarkable searches for a criminal ever conducted in the state of Montana.

### A Remarkable Story.

The story is remarkable in more than one way in that the news of the murder alleged to have taken place in the hills between Anaconda and Phillipsburg, was first received by the officers of Deer Lodge and Granite counties through a letter written by Sheriff R. M. Kennedy of Buffalo, Johnson county, Wyoming. Sheriff Kennedy stated that he came by his knowledge of the murder through W. E. Grovetant, who, previous to going to Buffalo, Wyo., had met near Billings, Mont., a woman who told him of a foul murder committed in Western Montana, between the cities of Anaconda and Phillipsburg.

### Daughter Accuses Father.

The story the woman told to Grovetant, as related to Sheriff Kennedy, and detailed in the letter, was to the effect that her father, her two little brothers, herself and husband were traveling overland through Montana. After passing through Phillipsburg, they proceeded up Flint Creek and camped in a point of timber on the south side of the road, at no great distance from the falls.

### Walbridge Is Missing.

While here Walbridge and Hunter left camp for the ostensible purpose of hunting elk. Walbridge never returned. Hunter, upon his arrival in camp, was covered with blood.

When Mrs. Walbridge accused her father of murdering her husband, he struck her senseless to the earth and then proceeded to burn his son-in-law's clothes, hide his saddle and some other accoutrements in the woods, and turn his horses loose.

## HALLOWEEN SPORTS.

### Anaconda Youths Meet With a Startling Surprise.

(Special to Inter Mountain.) Anaconda, Nov. 4.—Among the many depredations always performed by youthful characters on Halloween there are sometimes a large number that are extremely ludicrous and amusing. The only difficulty is in getting the boys to tell about them, for they would much rather assume a mysterious attitude and stand on the defensive, thus giving the impression that they have been mixed up in some of the worst scrapes ever perpetrated on the eve of November 1. The night of October 30 is known to the boys as clothes line and wood shed night, and they sally forth in parties and cut clothes lines and tip over wood sheds to their hearts' content.

On last clothes-line night, a party of boys approached a wood shed in the west end of town, and unthied their

forces turned it over on its side in a twinkling. To their surprise, there appeared where the woodhouse had been the figure of a woman, holding a lantern, and a small boy with an armful of wood. The boy had been late getting in the evening's supply of fuel, and his mother was assisting him. Both were in the shed when it suddenly upset and left them standing in the open air, watching numerous receding figures trying to get away from the circle of light cast by the lantern.

This is only one of many similar incidents that occur every year.

## YESTERDAY'S SHOOT.

### The Butte Gun Club Here as Guests of Anacondans.

(Special to Inter Mountain.) Anaconda, Nov. 4.—Contrary to expectations, there was no team shooting between the Butte and Anaconda clubs at Mountain View park yesterday, and the time was taken up entirely by individual scoring.

The Butte men reached town at 11 o'clock and were at once taken in charge by the local gun experts. They were taken direct to the Montana for lunch, and shortly after 1 o'clock Tom Fleming drove up with his big carryall wagon and conveyed the shootists to the park. The weather was a little bit winterish, but this was expected and the day before Ben Mahan went out and set up a tent, also a stove, so in that way the gunsmen were enabled to keep warm while they were not engaged.

Four events were with blue rocks and some time was devoted to live-bird shooting, in which no scores were kept.

McGivern of this city made the best score in the blue rock practice, 85 being his number; Yancy of Butte came next, with 81; Burton of Butte scored 77.

## LAYING PERMANENT TRACKS.

### One of the Important Things Being Done at New Works.

(Special to Inter Mountain.) Anaconda, Nov. 4.—Although the weather had a winterish tinge yesterday, that did not keep visitors away from the new smelter works.

The electric cars that went out that way in the afternoon were well filled with passengers who wanted to see the workmen putting on the finishing touches of the big plant.

Large gangs of men were at work yesterday and are again today, tearing up the railway tracks which were laid for temporary service during the construction of the works. The time has now come for permanent tracks and that is what is being done as rapidly as possible.

Yesterday the tracklayers were working on the approach to the immense ore bins to be used in conjunction with the blast furnace.

## DISTRICT COURT PROCEEDINGS.

### Committee Appointed on DeWolfe Resolutions.

(Special to Inter Mountain.) Anaconda, Nov. 4.—In the district court this morning the case of the state of Montana vs. Joseph Dulong was dismissed by Judge Welling Nanton upon motion of attorney for the defendant. The grounds of motion were based upon the fact that in the justice court where the case was originally tried the court exceeded its authority in several distinct phases. The bondsmen of Dulong were exonerated.

In the case of the seven gamblers now out on bail, the sheriff was ordered to appear in court with them this afternoon. Upon motion of T. O'Leary, a committee, consisting of T. O'Leary, Judge Whitehill, G. B. Winston, Hiram Rogers and C. M. Sawyer, was appointed to draft suitable resolutions upon the death of Judge Stephen DeWolfe.

The clerk of the court was ordered to issue a venire of 40 names for jurors, returnable Wednesday afternoon at 2 o'clock.

## Court Calendar Called.

(Special to Inter Mountain.) Anaconda, Nov. 4.—The civil and criminal court calendar will be called late this afternoon. The date for the trial of several cases was fixed this morning, and among them was the case of W. E. Thomas, clerk of the district court, against Phillip Greenan, county clerk and recorder, regarding the salary of the former. It was set for 9:30 o'clock a. m., November 6th. The case of George P. Hunter vs. John Dyer, was set for November 7th.

## FUNERAL OF THEO. EHRET.

### Anacondans Pay Last Tribute to the Respected Dead.

(Special to Inter Mountain.) Anaconda, Nov. 4.—Tender hands laid to rest all that is mortal of the late Theodore Ehret today.

Solemn requiem high mass was celebrated at 9 o'clock this forenoon at St. Paul's Catholic church. The full choir was in attendance, under the direction of Dr. J. F. Spellman, with Charles H. Hickey as organist.

Rev. A. R. Coopman acted as celebrant; Rev. Father De Siere of Butte as sacristan; Rev. Father Pierlot of Anaconda as deacon; Rev. Father O'Brien, chaplain of St. Ann's hospital, as sub-deacon; Rev. De Ryckere of Deer Lodge also assisted.

Shortly before 9 o'clock the remains, contained in a solid metallic casket weighing 900 pounds, was borne from the family residence on Main street and placed in the hearse which was then in waiting.

The procession was formed with the members of the National union, of which organization the deceased was a member, behind them came the A. O. U. W., the Degree of Honor, the ladies auxiliary of that order; then the Ladies' Catholic Benevolent association. Next came the hearse, followed by the carriage containing members of the bereaved family, behind whom came friends in a long line of carriages.

The church was decorated much the same as it was at the time of the funeral services held here for the late Marcus Daly, great streamer of black hanging from the ceiling with the ends fastened on either side.

The floral offerings were many and beautiful, contributions from the many friends of the deceased.

The altar of the church was covered in profusion with them, including a large number of artistic designs. Upon the coffin, as it lay in the aisle before the altar, were placed several beautiful wreaths.

At the conclusion of the ceremonies the remains were conveyed to Calvary cemetery, where they will be temporarily and until they are removed to be shipped to Europe for final interment. Theodore Ehret in life was one of Anaconda's most charitable and popular citizens. It is doubtful if any man in Deer Lodge county had more friends than he.

## CAIRNS REVIVAL MEETINGS.

### Occurred Last Evening at the Baptist Church.

Anaconda, Nov. 4.—George Robert Cairns, the noted evangelist, who has come to Anaconda to conduct a series of revival meetings at the Baptist church, was greeted with large congregations yesterday, both morning and evening. Last night particularly, the house was packed, and he delivered one of the powerful sermons characteristic of him. His subject was "Necromancy," taken from the text, "Ye must be born again."

The necessity of being born again, the source of the new birth and the effect of the new birth, were three thoughts dwelt upon by Mr. Cairns in his discourse, and made beautiful illustrations of the man who had through his acceptance of the word of God taken on a new heart and a new nature. The speaker showed how a man who has been sinful in the past abhors it after taking on this change of heart.

The revivals will be held all of this week, commencing each evening, except Saturday, with song services at 7:45 o'clock.

## Shipped East for Burial.

(Special to Inter Mountain.) Anaconda, Nov. 4.—The remains of the late Otto Berthels, who died at St. Ann's hospital last Saturday afternoon, will be shipped to Wisconsin tonight for burial. They will be accompanied by the young widow, who is stricken with bereavement only a few months after her marriage. The body will be escorted to the depot by members of the Anaconda Clerks' union and the Scandinavian Brotherhood, of which organization the deceased was a member.

## Brought Home Some Venison.

(Special to Inter Mountain.) Anaconda, Nov. 4.—William Morgan, chief clerk in Greig's store, returned last night from a three weeks' hunting expedition to Gallatin county. He brought home with him a fine young venison as an evidence of his grand marksmanship. He was accompanied by some Bozeman parties. The game was killed near the line of the Yellowstone Park.

(Special to Inter Mountain.) Anaconda, Nov. 4.—The members of the Fraternal Order of Eagles held a social session in Standard hall last night, to which they invited a large number of friends. The Eagles are royal entertainers and they showed their guests how to have a royal good time.

## MUST TRAIN SOLDIERS.

### Demand for Mounted Men in South Africa Greater Than Supply.

(By Associated Press.) New York, Nov. 4.—Commenting upon the South African military situation, a London correspondent says: It is understood to be the intention of the war office to send 5000 more mounted men out to South Africa during the next six weeks.

There are only about 7000 mounted men at home, so that the military authorities are faced with the problem of training soldiers, minus the necessary accompaniment of cavalry arms.

To meet this obvious falling it is probable that several composite regiments of yeomanry will be voluntarily embodied for home service.

A move will soon be made to bring home from South Africa the men who have served over two years in the war, and their place may be taken by the British cavalry division of seven regiments now in India.

After the conclusion of hostilities it is expected that a permanent garrison at the cape will consist of 50,000 men.

## EASTERNERS BUY MINE.

### Elkton Consolidated Co.'s Property Transferred at Large Valuation.

Colorado Springs, Nov. 4.—Control of the Elkton Consolidated Gold Mining company, on the property of which a remarkably rich strike was made recently, has passed into the hands of Eastern capitalists for a consideration based on a valuation of \$5,500,000 for the entire capitalization. The names are withheld for the present by E. Dwyler, the local agent and a prominent stockholder.

The deal is perhaps the largest involved in Colorado mining property since Stratton's chief independence was sold in April, 1899, for \$10,000,000. In local mining circles it is thought that the purchasers are New York capitalists who represent E. H. Bert & Co., who have sought to buy the mine.
