KNOWS MORE THAN MANY OTHER MEN

PETER PETERSON IS WELL AWARE OF THE FACT THAT HE IS CRAZY.

ACKNOWLEDGES IT, TOO. WITH NIAGARA OF WORDS

Does Not Give Examining Doctors Any Time to Talk About His Sanity—Complains of the Manner Mentally Weak People Are Treated by "Kings and Emperors"—Sister Killed Herself.

Peter Peterson, a crazy man, gave an excellent exhibition of the power of the human talking machine in Judge Harney's court this morning. Peterson is the German who was sent here by the state of Nebraska from the Lincoln insane asylum because he lived here before he went to Nebraska, and he was on trial for insanity.

Peterson is aware that he is crazy, and the first thing he did was to make the announcement to the court and the examining physicians. At the conclusion of the examination he was committed to the asylum.

He started to talk the instant he was brought into court and given a seat, and he was the last man to pass a remark when they were taking him away. He seems to be loaded with talk that he had to get rid of and to be under the impression that he would not have enough time.

"My sister knew she was crazy going and she herself killed her," he said. Strangely enough his sister committed suicide here a few years ago, and Peterson remembered the fact. It is said that she was losing her mind when she took her life.

Condemns Potentates. Peterson seemed to have the manner in which insane asylum patients are treated in Europe on his mind. He said that the kings and emperors in the old world took a malign pleasure in beating, kicking, choking and otherwise mistreating insane people.

"Dei in der stomachs pound dem; dey hit dem der nose on; dey choke dem by der throat. Ve gan hardships such as dose nit stand, mine friends. Zuch droubles und hardships was break down der strongest man in der world. Dey me nit hit myself. Nein. But vas abuse der insane beoples very derrible," he declared.

He is a short fat German with a flaring taffy mustache and a round red face, and his excitement was intense. His eyes glared and his face worked.

Human Talking Machine. His words simply tumbled one over each other. They flowed out in a steady stream and nothing could halt him. The doctors could not get a word in edgewise. He had not time to answer questions. He was absorbed with his subject. Nothing else interested him. He talked and talked as if his life depended upon it, and the everlasting theme of the outburst was the treatment of the insane.

When the verbal examination was over the physicians struck his knees and elbows for the physical signs of aberration and then returned a verdict of guilty as charged. His eloquence had been wasted. When he was being removed by the bailiff he said: "You, der doctors, have very kind been. It now is der American beoples up to der insane beoples to look after already."

Potosi Hot Springs. BILLINGS GAMBLERS IN STATE OF MILD PANIC

I. D. O'Donnell Demands That Green Cloth Fraternity Be Put Out of Business.

"There is a crusade against gambling in Billings and just at present the fraternity in the town is wearing the worried look," said a man from Billings this morning.

"Attorney General Donovan's move against the gamblers in his home town of Great Falls seems to have infected other patriotic Irishmen of Montana, and Billings, always getting in on anything at the first, produced I. D. O'Donnell, who is after the gamblers with a sharp stick. He has been collecting evidence and promises that when he gets through with his crusade there won't be a gambling place open in town.

"Of course, O'Donnell has followers. Carrying Nation had followers, you know. O'Donnell declares that the anti-gambling law ought to be enforced, and as nobody else seems patriotic and law-abiding enough to see that the law is enforced HE will. And I guess he will."

This guess by the man from Billings was right. A dispatch to the Inter Mountain today says that O'Donnell filed with the county clerk yesterday afternoon a paper bearing his own bold signature a protest against gambling and naming the gamblers.

DECLARES THERE IS NO FRICTION

CHIEF OF POLICE REYNOLDS AND JUDGE BOYLE INDIGNANT OVER STATEMENT IN PAPER.

JUDGE SAYS HE HAS NOT CRITICISED REYNOLDS

States That He Is Quoted Falsely in Every Particular, and the Chief Says Article Is of Whole Cloth—Both Men Speak of Charges Made by the Newspaper as Malicious.

Police Judge Boyle and Chief of Police Reynolds are indignant over an article published in a morning paper to the effect that there is friction between the magistrate and the office of the chief of police.

The article in question was ostensibly an account of the trial of four men in police court yesterday afternoon charged with being supported off the earnings of disreputable women, but in reality it was a combined "roast" and criticism of both the police judge and the chief.

That part of the article which aroused the ire of the officials referred to states in substance that there is friction between Judge Boyle and Chief Reynolds and that the judge is not satisfied with the manner in which the "chief is said to be collecting money from secretaries." The article states further that Judge Boyle announced from the bench that he was aware the accused men had paid for protection "down below," at the same time making a gesture to indicate that it was the chief he referred to.

Judge Makes Denial. "I want to denounce that article as false in every particular," said Judge Boyle this afternoon. "I did not say or insinuate that the chief was collecting fines which should have been paid into my court. That would have been a direct attack on the integrity of Chief Reynolds, whom I know to be an honest, painstaking official. What I did say was that the so-called 'secretaries' had reported that they would not be fined, as money had already been collected from them by the police. I told them that such reports would not protect them and I fined them accordingly."

Chief Is Indignant. Chief Reynolds was even more angry than the judge. Said he: "That article was cut from the whole cloth. It is a fabrication pure and simple, and was manufactured in the imagination. I have asked several men who were present when the alleged remarks of Judge Boyle were made, and they all told me that the judge made no remarks that could be construed to reflect on my department.

"As for collecting money from these men who make their homes in Galena street resorts that is a lie on the face of it. I have had those men approach me privately and offer me money to square them with the law, but I always flatly refused to listen to such propositions. I am determined that that gang of men living on the earnings of Galena street women shall be broken up and Judge Boyle is lending me his hearty co-operation in the matter."
