**ONE WEE WOMAN HAS 'EM ALL BUSY**

MRS. GEORGIE VANTZ CREATES CONSTERNATION AMONG OFFICIALS AT THE CITY BASTILE.

**WHISPERED LIKELIHOOD OF INTERESTING EVENT**

Physician Came on the Gallop, Prepared to Wrestle With the Dark Angel, and Find Mrs. Vantz Was Suffering From an Overdose of Green Cabbage—Everybody Was on the Move.

Mrs. Georgie Vantz has the hoarse horse laugh on County Physician Donnelly. She is a small dark-skinned young woman and looks like she might be of French or Italian extraction, and she may or may not have had method in her madness, but she certainly is eccentric.

She is in jail at the courthouse. She is there voluntarily. There is no charge against her, and she is a captive only because she desired to be.

Last night, at the witching hour of midnight, Mrs. Vantz had the jail and the sheriff's office in an uproar and fetched the county doctor down to the jail at double quick time, and the joke lies in the way that was accomplished.

She complained that she was in pain and whispered an interesting story to the officers, and the doctor, was brought to the bastille forthwith to attend her. Mrs. Vantz told the officials and the doctor that a baby was about to be born and that she was convinced that the event would occur in very short order.

Everybody Got Busy.

The birth of a baby is no small matter and Under Sheriff McGuigan and the rest of the staff chased themselves around the office on the jump, trying to do something that would make things easier, and the doctor tumbled out of his warm bed, filled his grip with medicine and other necessities and sprinted for the bastille.

Dr. Donnelly found the woman in pain without doubt, if her groans and contortions were worth anything as enlightening symptoms, but after a very careful diagnosis he discovered that her view of her situation was an absolute mistake, and full of disgust he left a prescription for stomach trouble and went home.

Under Sheriff McGuigan had retired before the doctor had made his diagnosis, feeling that his training had not made him specially valuable in the existent contingency, and this morning Dr. Donnelly strode into the sheriff's office and made his report.

Had Case of Colic.

"That woman is not going to have a baby," said he. "She must have eaten green cabbage or something. And she is married. I told her to leave the jail and go home and behave herself."

Mrs. Vantz had told the physician, as she had told the officials, that she was a single woman.

The first appearance of the woman at the courthouse yesterday was made at County Attorney Breen's office, where she related a story about how she had been ousted from her rooms in the town because she was unable to pay rent. She said that her \$14 accordion and her sewing machine, upon which she had paid \$20, had been confiscated, and that her husband was in Idaho, at Pocatello. County Attorney Breen called the husband over the long-distance telephone, and Mrs. Vantz talked with him, but to no end, apparently.

During the day she visited Judge Arnold's court and related her woes there. At the close of the day she came back to the courthouse and was allowed to remain over night in the woman's department of the jail, with the results stated. Around the courthouse she is thought a little light-minded, and the county physician has a very poor opinion of her sense of honesty and propriety.

**LEAR SECURED MONEY UNDER FALSE PRETENSE**

So, at Least, Charges Simon Bank, Who Has Louis Hauled Into Court.

Louis Lear was arrested in Justice Arnold's courtroom yesterday on a charge of obtaining money under false pretenses from Simon Bank, a money lender, and was ordered to give a bond of \$250 for his appearance in court. It is alleged that Lear borrowed \$100 from Bank and gave him a mortgage on 15 head of horses he did not own, and the matter was brought out in the trial of the suit of Bank against Mrs. J. Rippingale to quiet title to the animals. On the witness stand Mrs. Rippingale swore she owned the horses and the justice gave her judgment for them. H. L. Maury, who represented Bank in a legal capacity, then had Lear arrested on the charge stated. Lear was a witness in the case, which accounts for the fact that he was in the courtroom.

**MORTGAGEE FINDS ONLY ATMOSPHERE**

D. GRANT LOANED TAILOR MITCHELL \$30 ON HIS SHOP, SO HE ALLEGES.

**FOUND CHATTELS GONE WHEN NOTE FELL DUE**

Executor of Mortgage Discovered That the Goose Had Flown, and With It All the Valuables Upon Which the Money Had Been Loaned—Grant Enters a Complaint.

Deputy County Attorney Lynch today issued a complaint charging Henry Mitchell, a tailor, with the offense of removing mortgaged property from the place where it was situated when mortgaged, with intent to defraud the mortgagee. The complainant was D. Grant.

Grant told the official that he had loaned Mitchell the magnificent sum of \$30 and taken a mortgage on his stock of tailoring goods for the brief period of 10 days. He foreclosed the mortgage when the note fell due, and then he attempted to execute upon the 17 pieces of cloth samples, the blind goose and the other effects of Mitchell.

But he could not find the mortgaged chattels. He says that Mitchell made away with them between the time the mortgage was executed and the foreclosure. The goose had escaped and with it all the stripings for trousers and the green, red and yellow patterns with the horseshoes on them for vests.

Mitchell's place of business is at 208 East Park street, and when the mortgage was given to Grant it was stocked with goods worth at least \$50. At present Grant declares it is stocked with thin air, and the departure of the goose has made it lonely and desolate.

He is chiefly concerned in getting his \$30 back, however, or something in the way of satisfaction. The complaint was filed by him in Judge Olson's court in South Butte.

**SUES WESTERN UNION FOR \$50,000 DAMAGES**

Thomas McLaughlin, Arrested for Wire-Tapping and Acquitted, Is Damaged in Reputation.

Attorneys Kirk & Clinton have brought a damage suit in the district court in behalf of Thomas McLaughlin against the Western Union Telegraph company to recover the sum of \$50,000. The Western Union recently had McLaughlin, who was a former receiver of the Nipper mine, arrested on a charge of tapping its wires for the purpose of defrauding the Butte poolrooms.

McLaughlin was tried before a justice of the peace at Anaconda and acquitted. In his complaint against the telegraph company he says his arrest and imprisonment for several hours brought his integrity and reputation into disrepute to his great and irreparable damage in the sum of \$25,000, and caused him great humiliation and extreme mental anguish and injury to his feelings in the sum of \$25,000.

For these reasons he asks the court to award him a judgment for \$50,000 against the Western Union company.
