

DAILEY IS TO BE HELD FOR MURDER

CHARLES RAY DIES IN ST. JAMES HOSPITAL OF WOUNDS SAID TO HAVE BEEN GIVEN BY HIM.

Late yesterday afternoon C. A. Ray died at the St. James hospital. Ray was stabbed in a street fight last Saturday night on Broadway by E. J. Dailey. The wound in the leg was a bad one and gangrene set in. For that reason it became necessary to amputate the member at the hip and the shock of the operation was too great for the weakened man to resist.

Charles Ray was well known in Butte. He came here about 10 years ago from his home in Pennsylvania. Under Mayor McCarthy he was a member of the police force. Since that time he has lived chiefly by his wits. He is said to have been a graduate of a pharmacy school in the East. Ray leaves a wife and two children who are in the East. His uncle, F. J. Wallace of Norris, Mont., has been notified of Ray's death and until he is heard from no definite arrangements for the funeral will be made.

Now that C. A. Ray has died the charge of murder will be made against Dailey. Dailey has been in the county jail ever since the unfortunate affair happened. It is said that he was intoxicated at the time of the cutting. The men had had an argument.

SCHOOL TRUSTEES WANT TO SELL THAT BUILDING

But There is Apparently No Purchaser in Sight for the Meaderville Edifice as it Stands.

Clerk Richards stated to the meeting of the board of trustees last evening that under instructions from the board he had been negotiating for the sale of the Franklin school at Meaderville, but had so far been unsuccessful. The building committee was given power to either rent or sell the building.

The final details of closing up the big bond sale was attended to yesterday, and it will now be but a few days until the district will have \$100,000 to its credit.

It is expected that the new McKinley building on West Park street will be enclosed before winter sets in and compels a suspension of work. The building will not be ready for use until next year.

COWLES' DEATH DUE TO SUICIDE

SO DECIDES CORONER JOHNSON'S JURY AFTER SITTING OVER THE REMAINS.

Coroner Johnson held an inquest on the body of John Cowles last night. The dead man was found Wednesday morning in an out-house near a ranch south of the city in a lifeless condition. After examining all of the data obtainable, it was decided that the man's death was due to suicide. John Corn was the chief witness and he testified that Cowles was in an intoxicated condition the night before.

It was known that Cowles was intending to come to Butte to vote on Tuesday, but he was too much under the influence of liquor to do so. The next day the door of the outhouse was found to be locked and on opening it with a crowbar the dead body of Cowles was found there. J. N. Ethier and Louis Spini testified to the finding of the body.

ASSOCIATED CHARITIES ISSUE APPEAL FOR AID

FISH FOR SHORT LINE

Placing 10,000 in Rivers Along Road in Montana and Idaho.

William E. Smith of the United States Commission of Fish and Fisheries was one of the visitors at Short Line headquarters, says the Salt Lake Tribune. Mr. Smith has a car of the commission, which is now at Pocatello, but will make a tour over the whole of the Short Line, distributing various species of trout in the Snake, Port Neuf and other rivers, as well as their tributaries. He has 10,000 of the fish on the present trip, each being an inch or more in length, and which when deposited in the streams will mature rapidly, so that next summer the fishing will be greatly improved in that region.

The car is a moving aquarium, fitted up for the express purpose of transporting fish. There are several of the cars owned by the commission, which spends considerable time in stocking the streams of each state with fish. The whole of the present carload will be distributed along the Short Line in Idaho and Montana.

CHARGED WITH MOST EVERYTHING

JUDGE BOYLE WONDERS WHETHER DOE HAS OMITTED TO DO ANYTHING ON CRIMINAL CALENDAR.

Blinkey-eyed, and much the worse for hard wear, John Doe was arraigned before Judge Boyle in police court this morning. When his case was called by Clerk Winn, the man shook himself as if awaking from a dream, and shambled up to the bar of justice. Bracing himself upon the judge's desk, he looked up at him pitifully with a pleading air.

The first charge that was read to Doe accused him of fighting in the red light district. The man was not very solid on his pins, and, shaking his head mournfully, he answered the question "guilty or not guilty?" in the affirmative. For this he was fined the minimum of \$10. Then another complaint against the man was read for resisting an officer. Doe was not of the opinion that he ought to be made to answer to this charge, and he refused to acquiesce. Action in the matter was deferred.

When Clerk Winn prepared to read the third complaint Judge Boyle looked very much surprised that there should be so many charges against the unfortunate man, and he said:

"Can't you put the charge of murder against him also?"

Doe took a brace at this expression of sympathy, and, giving expression to his indignation by stretching himself to the limits of his shrunken physique, he took exception to the complaint that charged him with being a vagabond.

In dramatic tones and with an emotional gesture, he said:

"For God's sake, judge, ain't you goin' to give a poor wretch a show?"

And as the poor wretch stood there supplicating, the judge was moved in spite of his hardened look, and granted the man a respite until tomorrow, when the case will have a thorough hearing.

BUNCH OF VAGRANTS ARE UP BEFORE JUDGE BOYLE
