

# SACRED CONCERT AT ST. PATRICK'S KIRK TO RAISE FUNDS FOR A NEW ALTAR RAIL

St. Patrick's church in this city will be the scene of a grand sacred concert tomorrow evening, at which some exquisite music will be produced, or the delight of all who attend. The object of the concert is to secure funds for the purchase of a new altar rail for the church and the ladies who have in charge have made elaborate preparations to insure its success.

Besides some of the best musical talent in Butte a number of well known society singers and musicians of Anaconda will come up from the Smelter City to render their aid towards making the musicale a notable affair.

Mrs. Dr. Donnelly and Mrs. Rooney, members of the church, have charge of the concert and their experience in social matters and entertainments of the kind is a guarantee that this one will be all that is promised for it. The concert is given under the tutelage of the ladies of the League of the Sacred Heart, and Rev. Father McGlynn is at the head of affairs in an advisory capacity.

It is expected to make this one of the notable society functions on the eve of Lent, and it is also desired to raise the funds necessary to pay for the altar rail,

which is being made in Chicago at present and which will cost \$1,000.

## TWO WOMEN WHO WANT DIVORCES

Mrs. H. L. Hollis and Mrs. Ruth E. Crossly Want Separations.

### CONTINUAL ABUSE AND DESERTION ALLEGED

Old Tales of Vows Violated Soon After Leaving the Altar and Love Growth Cold Which, on Entering Life, Had Seemed, in the Roseate Hues of the Honeymoon, Destined to Last Forever

Two women who found marriage a failure told their tales of woe in the district court this forenoon.

One was young and pretty and looked as if life's cares sat lightly on her shoulders. The other was prematurely old and the lines on her face showed that she had suffered most.

The first was Mrs. H. L. Hollis, who after three months of married life felt compelled to appeal to the court to release her from her marital ties.

Mrs. Hollis appeared in Judge Clancy's division. She was handsomely gowned

and a picture hat of white adorned her head, which is crowned with a mass of dark brown hair. She is petite in figure and more than passing fair.

#### Continual Abuse Alleged.

Her story was one of continual abuse and cruelty at the hands of R. D. Hollis from April, 1902, when they married in this city, until the latter part of the following month, when she was compelled to flee from her husband, whom she declared had threatened to kill her.

From the time the couple left the altar, Mrs. Hollis declares, her husband entered upon a career of dissipation. Every night, she declared, he would come home drunk and abuse her in a most shameful manner. During their brief married life, she testified, he did not contribute one cent toward her support. One specific act of cruelty, she alleged, occurred one night during the latter part of May, 1902. Mrs. Hollis was confined to her bed by illness, when her husband came home drunk and ordered her to get up. As she arose he struck her with his fist, knocking her down, and threatened to kill her.

#### This Was the Climax.

This act appears to have been the climax and Mrs. Hollis sought refuge with friends. Shortly after that Hollis packed up his traps and fled, he being now a resident of Honolulu.

No children came from the union. The prayer of the woman for an absolute divorce and the restoration of her maiden name, Hannah Louise Johns, was granted by Judge Clancy.

It was in Judge Harney's department of the district court that the other woman told her story. Her name is Ruth E. Crossly and she sought a divorce on the ground of cruelty sustained during a number of years at the hands of J. C. Crossly, who had promised some 15 years ago to love and cherish her.

#### Of Long Duration.

The troubles of the couple date back several years. The husband, it appears, was of a jealous disposition and frequently accused his spouse of unfaithfulness. Finally they separated, but matters went along about the same. There was trouble over the children and in regard to their maintenance. The agreement was that the wife should have the custody of their offspring—seven in number, the eldest being 14 years old; that she should occupy the family residence and be allowed \$25 a month for support of the children.

Recently the wife decided to free herself entirely from her spouse and suit for divorce was filed.

The substance of the woman's story as related was told in Judge Harney's court this morning, and Mrs. Crossly's prayer that she be granted an absolute divorce, the custody of the children, \$25 a month alimony and \$50 counsel fees was granted.


There were many narrow escapes and some of the occupants have not been accounted for. The report that a number of Italians lost their lives has not been confirmed.


Replacement of Lost Teeth by Porcelain Undetectable From Natural Teeth




This shows a mouth with only four teeth left.

The figure shows a mouth with four front teeth gone.




This figure shows the 4 front teeth replaced



This shows two side teeth missing.




This shows them replaced.
