

THEY'RE AFTER GROVE.

Officers of the American Order of Home Protection Have an Ax Sharpened.

They Say They Have Positive Proof His Game's a Gigantic Swindle.

And They Will Use All Lawful Means to Help the State Officers Bring Him to Justice.

Since the sufferings of the colored people at Conza ridge become public, and one of unfortunate died from the effect of exposure there, the officers of the American Order of Home Protection have been investigating the schemes of Charles Porter Grove, who is held responsible for inducing the men now in the camp to leave Chicago and come to Montana.

Whereas, It has come to the knowledge of the officers of the American Order of Home Protection, that one Charles Porter Grove, now in the east, is basely misrepresenting to all the colored people he can reach, the condition of certain so-called mines, of which he pretends to be the owner, and by so doing is inducing them to invest their money and come to this state, and

Whereas, We have positive proof that his scheme is a gigantic swindle, and by so inducing men to come to this state in the expectation of obtaining work he is deceiving them, and is the direct cause of great suffering, and we believe in one case at least the death has ensued from his failure to provide his men with sufficient shelter, and

Whereas, This association is the only national association which admits colored people to membership, we believe it is our duty to appropriate our membership, and the colored people generally, of G. O. V.'s fraudulent operations, and to take all lawful means to bring him to justice for his disreputable conduct. Therefore, be it

Resolved, That the executive officers of this order be and are hereby directed in the name of this order to communicate the true facts relating to Grove's swindle to the several councils of our order and to the papers published in the east in the interest of the colored people, and if a case of action can be established to assist the prosecuting officers of this state to cause his arrest and punishment.

Francis, of Missoula. J. M. Clements, of Helena, appeared for the defendant. On Oct. 17 last a half-breed Galloway heifer belonging to Joseph R. Skelly, living near Thompson Falls, was hit by a Northern Pacific train and killed. Skelly brought suit against the road before W. R. Hamilton, justice of the peace at Thompson Falls, claiming \$70 damages. A copy of the summons was left with J. S. Tyler, the railroad's agent at Thompson Falls. Counsel for the road made a motion to quash and set aside the summons on the ground that there had been no service and that the justice's court had no jurisdiction. Justice Hamilton denied the motion and went ahead and tried the case, giving Skelly judgment for \$50, which he considered the value of the heifer. It appears that, according to the papers in the case, that the justice "issued a writ of injunction on his judgment and placed the same in the hands of one Chas. S. Good, a constable, who served a copy of it on J. R. Tyler, agent at Thompson Falls." Counsel for the receivers of the Northern Pacific applied to Judge Knowles for a writ of injunction to prevent the enforcement of the judgment. A temporary restraining order was issued some weeks ago, and the justice of the peace and others interested ordered to show cause why it should not be made permanent. Yesterday Judge Knowles made the injunction permanent.
