A PIONEER WOMAN IS DEAD

MRS. JOHANNA SCHRIBER, 83 YEARS OF AGE, DIES AT HOME SOUTH OF CITY.

Mrs. Johanna Schriber, one of the well-known pioneer women of this city, died yesterday afternoon, about 3 o'clock, at the home of her son, Henry Schriber, south of the city. She was in good health and had a splendid vitality up to Thursday, June 1, when she slipped on a board and had to be carried into the house. The Sunday preceding her fall she had walked three and one-half miles to church in the city and on Monday had visited the home cemetery. Since her fall, just a week ago, she was in poor health and had been in bed. She retained her cheerful disposition up to the time of her death, which occurred soon after the doctor had visited her and said that her heart was strong.

Mrs. Schriber, nee Kellbrech, was born in Saxony, Germany, June 6, 1826, making her just 82 years of age the day before she died. She was married in Germany in 1849, to Christopher Schriber, moving to this country in 1852. She came with her husband to Missoula in 1885, and had always made her home with her son, Henry, who is well known in Missoula. Mr. and Mrs. Schriber celebrated their golden wedding in this city on February 24, 1899. Mr. Schriber died in 1901.

Mrs. Schriber was a well-known woman, who was loved by all who knew her. She was blessed with a kind heart and a most cheerful disposition, so that she will be missed by a host of sympathizing friends. Besides her son, Henry, she is survived by another, John. She leaves several great-grandchildren.

The funeral will be held tomorrow afternoon at 3 o'clock from the German Lutheran church, Rev. Gustave Mertz officiating. Burial will probably be in the Higgins cemetery, south of town.
