Talk of forming a new major league in baseball in opposition to the present National and American leagues has caused the fans to call to mind the earlier history and the peculiarities of some of the leading men now in the game.

Professional baseball owners and managers come from all walks of life and hundreds of stories are told of their peculiarities. It is a recognized maxim that a successful baseball manager must have more or less sporting instincts.

The most prominent of the owners in the game is Charles P. Taft, brother of President Taft, multimillionaire and owner of a Cincinnati newspaper.

Garry Herrmann, chairman of the National Baseball commission, is known as a baseball man because of the constant mention of his name in connection with the commission and his ownership of the Cincinnati National league club.

John McCloskey, manager of the Milwaukee team this year, is known as the "ball players' friend." He gained the sobriquet by his habit, when a National league manager of signing young players to major league contracts to give them a record of having once been in fast company.

Charles Comiskey, owner of the Chicago Americans, is the ideal baseball owner. He was one of the greatest strategists and players the game ever produced.

Harney Dreyfuss, owner of the Pittsburgh Pirates, was a business man in bad health in Paducah and Louisville, Kentucky, before he took an active interest in baseball.

Probably the greatest character in the game is Joe Cantillon, manager and, with his brother Mike, owner of the Minneapolis club which won the American association championship this year.
